NOTICE IS HEREBY GIVEN THAT:

1. The above named Appellant, A&B IRRIGATION DISTRICT ("Appellant") appeals against the above named respondents to the Idaho Supreme Court from the district court's *Memorandum Decision on Petition for Judicial Review*, entered in the above entitled action on April 25, 2013, the Honorable Eric J. Wildman presiding. Judge Wildman entered a Rule 54(a) final judgment on April 25, 2013.
2. The above named Appellant has a right to appeal to the Idaho Supreme Court, and the order described in paragraph 1 is an appealable order pursuant to Rule 11(a)(1), I.A.R.
3. The Appellant's preliminary statement of issues it intends to assert on appeal, which under I.A.R. 17 does not prevent the Appellant from asserting other issues, is as follows:
 - a. Whether the District Court erred in dismissing A&B's petition for judicial review of the Director's April 27, 2011 *Final Order on Remand Regarding A&B Irrigation District Delivery Call*?
 - b. Whether the District Court erred in application of the exception to the mootness doctrine?
 - c. Whether the District Court erred in stating A&B waived the issue of the Director's failure to apply the CM Rules in the evaluation of whether junior ground water right holders were "wasting" water?
 - d. Whether the District Court erred in stating A&B attempted to improperly appeal the Director's material injury analysis?
 - e. Whether the District Court erred in concluding I.C. § 42-226 allows for a consideration of "alternative means of diversion" not related to a reasonable groundwater pumping level?
