The City of Pocatello (“Pocatello”), by and through its counsel White & Jankowski, LLP, hereby petitions to be designated as a “Respondent-Intervenor” in the above-captioned proceeding and to amend the caption accordingly.

The above-captioned matter before this Court concerns A&B Irrigation District’s third appeal of its delivery call proceeding before the Idaho Department of Water Resources. *See generally A & B Irr. Dist. v. Idaho Dep’t of Water Res.*, No. 39196-2011, 2012 WL 4055353 (Idaho Sept. 14, 2012); *A & B Irr. Dist. v. Idaho Dep’t of Water Res.*, 153 Idaho 500, 503, 284 P.3d 225, 228 (2012). Pocatello was designated as an Intervenor-Respondent in both prior appeals. *See* 153 Idaho 500, 284 P.3d 225; *Order Amending Title*, Supreme Court Docket No. 39196-2011, SRBA Case No. 2011-512 (Idaho Dec. 14, 2011).

In the above-captioned proceeding, Pocatello was designated as a “Respondent-Intervenor” by the district court. *See* Exhibit A attached, *Order Treating Appearance as Motion to Intervene and Granting Same* (Sept. 13, 2011). The caption of A&B Irrigation District’s Notice of Appeal dated June 4, 2013 incorrectly identifies Pocatello as an “Intervenor” and does not designate Pocatello as a party to this appeal. As explained above, Pocatello has been a respondent to these proceedings since their inception and is a party to this appeal pursuant to an order of the district court. Pocatello is materially affected by the outcome of this appeal, as Pocatello owns and operates water rights that may become the subject of curtailment orders.

Based on the foregoing, Pocatello respectfully requests that the Court designate Pocatello as a Respondent-Intervenor in the above captioned matter and amend the caption accordingly.


