Electronic Brief Instructions

*This page contains steps that **MUST** be taken for the hyperlinking in the electronic brief to function properly. These steps only require a total of five mouse clicks.*

This DVD contains a hyperlinked electronic version of the *Boise Project Board of Control's Appellant's Brief*. This hyperlinked brief is being provided for the convenience of the Court and the parties in reviewing the brief and is identical to the brief filed with the Court on May 26, 2017. Clicking the hyperlinked citations in the brief will open the corresponding portion of the record in a new window. The new window can be closed by clicking the "X" in the upper right corner.

In order for the hyperlinking feature to function properly, a few steps must first be taken.

1. This brief requires Adobe Acrobat Reader version 7 or newer. If you do not have an updated version of the Adobe Acrobat Reader, a copy of this software can be obtained at www.adobe.com at no charge.
2. After downloading an updated version of the Adobe Acrobat Reader, or, if you already have a current version of the Adobe Acrobat Reader, open your Adobe Reader program.
3. Select "Edit" from the main toolbar at the top of the document window.
4. Select the "Preferences" option from the bottom of the "Edit" menu.

5. Select "Documents" from the "Categories" list on the left-hand side of the "Preferences" window. If there is not a "Documents" option, then select "General."

6. **This is the most critical step:**

Uncheck the box for "**Open cross-document link in the same window.**" (This is the second or third checkbox from the top.

7. Click the "Ok" button at the bottom of the "Preference" window or hit "Enter."

After completing these steps, you are ready to view the *Boise Project Board of Control's Appellant's Brief* and to navigate through the hyperlinks. Should you have any questions, please feel free to contact me at (208) 336-0700.
