A JOINT MOTION TO SUSPEND APPEAL AND TO VACATE ORAL ARGUMENT was filed by counsel for the Ditch Companies in Supreme Court docket nos. 44677, 44746, and 44745 on April 18, 2018, requesting this Court to suspend the proceedings and to vacate the oral argument currently scheduled for May 7, 2018. Thereafter, the DEPARTMENT'S STATEMENT IN OPPOSITION TO MOTION TO SUSPEND APPEAL AND VACATE ORAL ARGUMENT was filed by counsel for the Department on April 23, 2018. IT IS HEREBY ORDERED that the Ditch Companies' JOINT MOTION TO SUSPEND APPEAL AND TO VACATE ORAL ARGUMENT and continue oral argument to February 15, 2019 be, and hereby is, DENIED however, should all parties file a Stipulation to reset oral argument to June, 2018, the motion will be reconsidered.

IT IS FURTHER ORDERED that the ORDER GRANTING MOTION FOR JUDICIAL NOTICE issued by this Court on April 24, 2018, is RESCINDED and the DEPARTMENT'S MOTION FOR JUDICIAL NOTICE AND STATEMENT IN SUPPORT is DENIED, however, the filing shall be allowed as additional authority.
