**STIPULATED MOTION TO MODIFY  
BRIEFING SCHEDULE**

Respondents-Cross Appellants, South Valley Ground Water District and Galena Ground Water District (collectively “Districts”), the Appellants-Cross Respondents, the Idaho Department of Water Resources and Gary Spackman (“Department”), amicus curiae Idaho Ground Water Appropriators (“IGWA”), and the other Intervenor-Respondents appearing in this case have conferred on and stipulated to an extended briefing schedule for this appeal. Pursuant to I.A.R. 34(d) and 46, the parties request an order extending the current briefing schedule consistent with this stipulation. The motion is supported by the Affidavit of Travis L. Thompson, filed concurrently herewith. The stipulated briefing schedule is:

**September 23, 2022** – the Districts’ (a) response to the Department’s opening brief and (b) cross-appeal opening brief; IGWA’s amicus brief; brief of any Intervenor-Respondent that supported the Districts in the district court.

**October 28, 2022** – the Department’s combined (a) reply brief and (b) cross-appeal response brief; brief of any Intervenor-Respondent that supported the Department in the district court.

**November 21, 2022** – the Districts’ cross-appeal reply brief.

The current due date for the Districts’ response/cross appeal brief is September 16, 2022. As explained in the supporting affidavit, the parties agree to a one-week extension for the Districts’ brief due to the circumstances described in the affidavit. The modified schedule provides sufficient time to address the exigencies that have occurred and will apply to all parties to ensure briefing continues in an orderly manner. There is good cause to accept the parties’ stipulation and grant this motion. The Districts respectfully request this Court grant the motion and modify the briefing scheduled as indicated above.
