Intervenor City of Hailey, by and through its attorneys of record, hereby joins in and supports the *Water District 37B Ground Water Association's Response to IGWA Statement of Issues* filed with the Idaho Department of Water Resources in the above-referenced docket.

Further, it appears from the November 4, 2016 Certificate of Service for the Department's *Order Designating the Snake Plain Aquifer Ground Water Management Area* ("GWMA Order") that IGWA's counsel and representatives for most if not all of IGWA's Ground Water District members were served with a copy of the GWMA Order. Like other potentially aggrieved parties, IGWA had fifteen days to file a written petition stating the grounds for contesting the action and requesting a hearing. Idaho Code 42-1701A(3). Only Sun Valley availed itself only that opportunity. These proceedings should not be expanded as proposed by

IGWA to include issues that could have been, and should have been, raised in a timely petition for hearing.
