ORDER EXTENDING SCHEDULING DEADLINE TO RESPOND TO IDWR'S EXPERT WITNESS REPORT

BACKGROUND

On September 25, 2019, the Director issued an order establishing a January 13, 2020, deadline for parties to respond to IDWR's response to expert reports. See Deadline for IDWR's Submittal of Materials; Order on Motion Practice; Notice of Hearing and Scheduling Order; Order Authorizing Discovery at 3. On January 13, 2020, Fremont Madison Irrigation District, Madison Ground Water District and Idaho Irrigation District, (collectively "UV"), filed a Motion for Extension of Time to Submit Response to IDWR's Response to Expert Reports ("UV Motion"). UV's Motion requests a one week extension of time from January 13, 2020, to Monday, January 20, 2020, for responding to IDWR's response. UV Motion at 1. UV contacted the parties and IDWR and no party objected to the requested extension.

ANALYSIS

The Director finds that good cause exists to extend the deadline one week for the parties to respond to IDWR's response to expert witness reports. Accordingly, the Director will extend the deadline for responses to January 20, 2020.

ORDER

IT IS HEREBY ORDERED that the deadline for the parties to respond to IDWR's response to expert witness reports is EXTENDED to January 20, 2020.
