Dear Director Spackman,

In accordance with your *Scheduling Order*, dated May 25, 2021, and delivered by Meghan Carter's email of May 25, 2021, Idaho Power Company responds to your request for clarification. Group 3, as your *Order* describes, includes Basin 37 water right holders (surface and ground water) who do not fall within the potential area of curtailment. It also appears that this group received the May 4, 2021, "Notice" as a holder of Basin 37 water rights. As a holder of Basin 37 water rights, Idaho Power Company received the above-referenced "Notice." As stated at the Pre-hearing conference, it doesn't appear that any of the rights are within the curtailment area. Hence, Idaho Power Company believes it falls within Group 3.

Additionally, at this time Idaho Power Company does not intend to call any witnesses or submit exhibits. It does reserve the right to cross-examine witnesses and participate in briefing, although it anticipates any such questions would be limited to either technical or administrative issues.
