- 2. Predicted Hydrologic Response in Silver Creek and the Little Wood River to Curtailment of Groundwater Use in 2021, Basin 37 Administrative Proceeding, AA-WRA-2021-001 (prepared by Jennifer Sukow)

Figure 13 was compiled from data available in the Supporting Files at SupportingFiles_Hydro\JrGWTool\InputFiles_Transient\3_WRVPOD\WRVPOD_2017.dbf. The spreadsheet version (WRVPOD_2017.xlsx) is submitted with this response.

b. Monthly volumes of curtailed pumping, return flows (e.g., WWTP returns and irrigation returns), and consumptive use for Bellevue, Hailey, Ketchum, and Sun Valley Company in all curtailment runs.

The curtailment runs only simulated curtailment of irrigation use. WWTP returns were assumed to remain the same as indicated in the baseline 2002 records and were not changed in the curtailed runs. Monthly volumes of estimated curtailed irrigation use were extracted from the model input files (available in the Supporting Files) for the simulations within the WRV1.1 model domain, and are provided in the spreadsheet RFI_GWCU.xlsx. The water users requesting this information were outside of the simulated area of curtailment south of Glendale Bridge, and therefore had zero curtailed pumping in those simulations.
