EAGLE CREEK IRRIGATION COMPANY'S POST-HEARING BRIEF

Eagle Creek Irrigation Company ("ECIC"), by and through Norman M. Semanko of the firm Parsons Behle & Latimer, filed its *Notice of Intent to Participate* in this matter on May 12, 2021, based upon the statement contained in the notice from IDWR that: "The administrative proceeding may affect surface and ground water rights beyond the Little Wood-Silver Creek drainage and Bellevue areas." *Notice of Administrative Proceeding Cover Letter* (May 4, 2021).

The Director clarified at the May 24, 2021 prehearing conference that the focus of this proceeding is ground water rights in the Bellevue Triangle area, not areas outside of the Triangle. See *Prehearing Order; Scheduling Order* (May 25, 2021) ("this proceeding is focused on ground water users in the Bellevue Triangle"). Accordingly, the hearing held from June 7 to 12 focused

primarily, if not exclusively, on ground water pumping and potential curtailment in the Bellevue

Triangle area.

As a result, ECIC hereby submits that its water rights – which are surface water rights on

Eagle Creek, located north of the Bellevue Triangle – are not subject to curtailment in this

proceeding. There are at least three reasons for this conclusion.

First, as discussed above, Eagle Creek falls well outside the defined scope of this

proceeding, as a source of surface water rights outside of the Bellevue Triangle area. Second,

Eagle Creek has been decreed as a separate stream in the Snake River Basin Adjudication and

ECIC's water rights are administered separately from all other water rights in Basin 37. Snake

River Basin Adjudication Final Unified Decree, Attachment 3 - General Provisions (Basin 37).

Third, the statute upon which the Director relies for the current administrative proceeding, I.C.

§ 42-237a.g, provides authority to manage ground water; it does not extend to surface water or

surface water rights.

Therefore, ECIC further submits that any order issued by the Director should be limited in

scope so as not to include Eagle Creek or ECIC's water rights.
