IN THE MATTER OF DISTRIBUTION OF WATER TO VARIOUS WATER RIGHTS HELD BY OR FOR THE BENEFIT OF A&B IRRIGATION DISTRICT, AMERICAN FALLS RESERVOIR DISTRICT #2, BURLEY IRRIGATION DISTRICT, MILNER IRRIGATION DISTRICT, MINIDOKA IRRIGATION DISTRICT, NORTH SIDE CANAL COMPANY, AND TWIN FALLS CANAL COMPANY	CM-DC-2010-001 FINAL ORDER CURTAILING GROUND WATER RIGHTS JUNIOR TO JUNE 14, 1977

The Director of the Idaho Department of Water Resources (“Department”) finds, concludes, and orders as follows:

FINDINGS OF FACT

1. On April 19, 2016, the Director (“Director”) of the Idaho Department of Water Resources (“Department”) issued the *Fourth Amended Final Order Regarding Methodology for Determining Material Injury to Reasonable In-Season Demand and Reasonable Carryover* (“Methodology Order”). The Methodology Order established nine steps for determining material injury to members of the Surface Water Coalition (SWC).¹

2. On April 19, 2021, the Director issued the *Final Order Regarding April 2021 Forecast Supply (Methodology Steps 1-3)* (“April 2021 Forecast Order”). The April 2021 Forecast Order predicted a demand shortfall (“DS”) to the SWC of 40,500 acre-feet for the 2021 irrigation season. *April 2021 Forecast Order* at 3. At that time, the only member of the SWC predicted to experience material injury during the 2021 irrigation season was the Twin Falls Canal Company (“TFCC”). *Id.*

3. As a result the Director ordered that, by May 1, 2021, ground water users with consumptive water rights “junior to May 30, 1989, within the Eastern Snake Plain Aquifer area of common ground water supply [(ESPA ACGWS)] shall establish, to the satisfaction of the Director, that they can mitigate for their proportionate share of the predicted DS of 40,500 acre-feet in accordance with an approved mitigation plan.” *Id.* at 6. The Director also ordered that, if a junior ground water user cannot mitigate for their proportionate share of the predicted demand shortfall in accordance with an approved mitigation plan, “the Director will issue an order curtailing the junior-priority ground water user.” *Id.*

¹ The SWC is comprised of A&B Irrigation District (“A&B”), American Falls Reservoir District #2 (AFRD2), Burley Irrigation District, Milner Irrigation District, Minidoka Irrigation District, North Side Canal Company, and Twin Falls Canal Company.

4. On May 20, 2021, the Director issued the *Final Order Curtailing Ground Water Rights Junior to May 30, 1989* (“May 2021 Curtailment Order”). The Director ordered that:

[A]t 12:01 a.m. on or before June 3, 20[21], ground water users holding water rights bearing priority dates junior to May 30, 1989, within the ESPA ACGWS listed in Attachment A to this order shall curtail/refrain from diversion and use of ground water pursuant to those water rights unless notified by the Department that the order of curtailment has been modified or rescinded as to their water rights.

May 2021 Curtailment Order at 3-4.

5. On July 20, 2021, the Director issued the *Order Revising April 2021 Forecast Supply (Methodology Step 6)* (“July 2021 Forecast Order”). The Director predicted a revised in-season demand shortfall of 170,000 acre-feet. *July 2021 Forecast Order* at 8. The Director concluded both TFCC and the AFRD2 were expected to experience material injury, with estimated times of need of August 20, 2021, for TFCC, and September 25, 2021, for AFRD2. *Id.*²

6. As a result, the Director ordered that by “August 3, 2021, ground water users holding consumptive water rights bearing priority dates junior to June 14, 1977, within the [ESPA ACGWS] shall establish, to the satisfaction of the Director, that they can mitigate for their proportionate share of the predicted DS of 170,000 acre-feet in accordance with an approved mitigation plan.” *Id.* at 10. The Director also ordered that if such junior ground water users cannot mitigate for their proportionate share of the predicted DS “in accordance with an approved mitigation plan, the Director will issue an order curtailing the junior-priority ground water user.” *Id.*

7. There are currently six approved mitigation plans in place responding to the SWC delivery call:

- (1) Docket No. CM-MP-2009-007 for the benefit of the Idaho Ground Water Appropriators, Inc. (IGWA) (delivery of stored water);
- (2) Docket No. CM-MP-2009-006 for the benefit of IGWA (conversions, dry ups and recharge);
- (3) Docket No. CM-MP-2016-001 for the benefit of IGWA (the IGWA and SWC stipulated mitigation plan);
- (4) Docket No. CM-MP-2010-001 for the benefit of the Southwest Irrigation District and Goose Creek Irrigation District (collectively, “SWID”);

² Shortly before the predicted time(s) of need, the Director will issue an order implementing Step 7 of the Methodology Order. Step 7 requires the Director to: (1) recalculate RISD; (2) issue a revised FS; (3) establish the Time of Need; and (4) revise the DS. *Methodology Order* at 38.

- (5) Docket No. CM-MP-2019-001 for the benefit of certain cities commonly referred to as the “Coalition of Cities”; and
- (6) Docket No. CM-MP-2015-003 for the benefit of the A&B Irrigation District (“A&B”).

8. In both the April 2021 Forecast Order and the July 2021 Forecast Order, the Director concluded that due to the nature of the approved mitigation plans for SWID, IGWA and the Coalition of Cities, these entities do not need to establish they can mitigate for their proportionate share of the revised predicted DS. *April 2021 Forecast Order* at 5, note 5; *July 2021 Forecast Order* at 10, note 3.

9. A&B's enlargement water rights (36-15127B et al.) were curtailed under the May 2021 Curtailment Order, and will remain curtailed under this order. The July 2021 Forecast Order concluded A&B's “other water rights are not affected by the adjusted curtailment date, thus A&B does not need to establish that it can mitigate for its proportionate share of the predicted DS in this order.” *Id.*

CONCLUSIONS OF LAW

1. Idaho Code § 42-602 authorizes the Director to supervise water distribution within water districts:

The director of the department of water resources shall have direction and control of the distribution of water from all natural water sources within a water district to the canals, ditches, pumps and other facilities diverting therefrom. Distribution of water within water districts created pursuant to section 42-604, Idaho Code, shall be accomplished by watermasters as provided in this chapter and supervised by the director.

The director of the department of water resources shall distribute water in water districts in accordance with the prior appropriation doctrine. The provisions of chapter 6, title 42, Idaho Code, shall apply only to distribution of water within a water district.

2. As explained above, by “August 3, 2021, ground water users holding consumptive water rights junior to June 14, 1977, within the [ESPA ACGWS]” had to “establish, to the satisfaction of the Director, that they can mitigate for their proportionate share of the predicted DS of 170,000 acre-feet in accordance with an approved mitigation plan.” *July 2021 Forecast Order* at 10. If a junior ground water user does not establish they can mitigate for their proportionate share of the predicted DS in accordance with an approved mitigation plan the ground water user will be subject to this “order curtailing the junior-priority ground water user.” *Id.*

3. Due to the nature of the approved mitigation plans for SWID, IGWA and the Coalition of Cities, these entities do not need to establish that they can mitigate for their

proportionate share of the predicted DS. Junior ground water users entitled to the protection of the SWID, IGWA and Coalition of Cities mitigation plans will not be subject to curtailment during the 2021 irrigation season.

4. A&B's enlargement rights were curtailed by the May 2021 Curtailment Order and those rights remain curtailed. *May 2021 Curtailment Order* at 3. However, A&B's other water rights are not affected by the adjusted curtailment date in this order, and, therefore, A&B has no new mitigation obligation under the revised DS. *July 2021 Forecast Order* at 10.

5. The Director concludes junior-priority ground water users that have not established mitigation of their proportionate share of the revised DS in accordance with an approved mitigation plan should be curtailed. Junior-priority ground water users subject to curtailment are listed in Attachment A to this order.

ORDER

Based upon and consistent with the foregoing, IT IS HEREBY ORDERED that, at 12:01 a.m. on or before August 4, 2021, ground water users holding water rights bearing priority dates junior to June 14, 1977, within the ESPA ACGWS listed in Attachment A to this order shall curtail/refrain from diversion and use of ground water pursuant to those water rights unless notified by the Department that the order of curtailment has been modified or rescinded as to their water rights. This order shall apply to consumptive ground water rights, including but not limited to, agricultural, commercial, industrial, and municipal uses. This order excludes ground water rights used for *de minimis* domestic purposes where such domestic use is within the limits of the definition set forth in Idaho Code § 42-111 and ground water rights used for *de minimis* stock watering where such stock watering use is within the limits of the definitions set forth in Idaho Code § 42-1401A(11), pursuant to IDAPA 37.03.11.020.11.

IT IS FURTHER ORDERED that watermasters for the water districts within the ESPA ACGWS who regulate ground water are directed to review the water rights listed in Attachment A to this order and contact the water right holders in their respective districts to effectuate the curtailment required by this order.



EXPLANATORY INFORMATION TO ACCOMPANY A FINAL ORDER

(To be used in connection with actions when a hearing was **not** held)

(Required by Rule of Procedure 740.02)

The accompanying order is a "Final Order" issued by the department pursuant to section 67-5246, Idaho Code.

PETITION FOR RECONSIDERATION

Any party may file a petition for reconsideration of a final order within fourteen (14) days of the service date of this order as shown on the certificate of service. **Note: The petition must be received by the Department within this fourteen (14) day period.** The department will act on a petition for reconsideration within twenty-one (21) days of its receipt, or the petition will be considered denied by operation of law. See section 67-5246(4), Idaho Code.

REQUEST FOR HEARING

Unless the right to a hearing before the director or the water resource board is otherwise provided by statute, any person who is aggrieved by the action of the director, and who has not previously been afforded an opportunity for a hearing on the matter shall be entitled to a hearing before the director to contest the action. The person shall file with the director, within fifteen (15) days after receipt of written notice of the action issued by the director, or receipt of actual notice, a written petition stating the grounds for contesting the action by the director and requesting a hearing. See section 42-1701A(3), Idaho Code. **Note: The request must be received by the Department within this fifteen (15) day period.**

APPEAL OF FINAL ORDER TO DISTRICT COURT

Pursuant to sections 67-5270 and 67-5272, Idaho Code, any party aggrieved by a final order or orders previously issued in a matter before the department may appeal the final order and all previously issued orders in the matter to district court by filing a petition in the district court of the county in which:

- i. A hearing was held,
- ii. The final agency action was taken,
- iii. The party seeking review of the order resides, or
- iv. The real property or personal property that was the subject of the agency action is located.

The appeal must be filed within twenty-eight (28) days of: a) the service date of the final order, b) the service date of an order denying petition for reconsideration, or c) the failure within twenty-one (21) days to grant or deny a petition for reconsideration, whichever is later. See section 67-5273, Idaho Code. The filing of an appeal to district court does not in itself stay the effectiveness or enforcement of the order under appeal.
