**SECOND ORDER AMENDING
CURTAILMENT LIST**

On May 30, 2024, the Director of the Idaho Department of Water Resources (“Department”) issued a *Final Order Curtailing Ground Water Rights Junior to March 31, 1954* (“*Curtailment Order*”). The *Curtailment Order* requires ground water users within the Eastern Snake Plain Aquifer area of common ground water supply (“ESPA ACGWS”), whose rights have a priority date after March 31, 1954, and who have not already established to the satisfaction of the Director that they are operating in accordance with a Department-approved mitigation plan, to cease diverting ground water under those rights. *Curtailment Order*, at 9. The junior-priority ground water rights subject to the order were listed in Attachments A and B to the order.

On June 6, 2024, the Director issued an *Order Amending Curtailment List* (“*Amended Curtailment Order*”). The *Amended Curtailment Order* amended the list of junior-priority ground water rights subject to curtailment by removing water rights that water users established to the satisfaction of the Director were operating in accordance with a Department-approved mitigation plan.

Since the Director issued the *Amended Curtailment Order*, additional water users with water rights listed in the Amended Attachments A and B have established to the satisfaction of the Director that they are operating in accordance with a Department-approved mitigation plan. As a result, the Director concludes that the list of junior-priority ground water rights subject to curtailment should be amended to remove those water rights.

Accordingly, the following water rights should be removed from the curtailment list:

- a. All water rights of members of Bingham Ground Water District.
- b. All water rights of members of Bonneville-Jefferson Ground Water District.
- c. All water rights of members of Carey Valley Ground Water District.
- d. All water rights of members of Jefferson Clark Ground Water District.

ORDER

Based upon and consistent with the foregoing, IT IS HEREBY ORDERED that the Amended Attachments A and B to the June 6, 2024 *Order Amending Curtailment List* are further amended as attached hereto. The water rights described above are no longer subject to curtailment. All other ground water rights listed in the Amended Attachment B¹ continue to be curtailed consistent with the timeframes listed in the May 30, 2024 *Final Order Curtailing Ground Water Rights Junior to March 31, 1954*.



EXPLANATORY INFORMATION TO ACCOMPANY A FINAL ORDER

(To be used in connection with actions when a hearing was **not** held)

(Required by Rule of Procedure 740.02)

The accompanying order is a "Final Order" issued by the department pursuant to section 67-5246, Idaho Code.

PETITION FOR RECONSIDERATION

Any party may file a petition for reconsideration of a final order within fourteen (14) days of the service date of this order as shown on the certificate of service. **Note: The petition must be received by the Department within this fourteen (14) day period.** The department will act on a petition for reconsideration within twenty-one (21) days of its receipt, or the petition will be considered denied by operation of law. See section 67-5246(4), Idaho Code.

REQUEST FOR HEARING

Unless the right to a hearing before the director or the water resource board is otherwise provided by statute, any person who is aggrieved by the action of the director, and who has not previously been afforded an opportunity for a hearing on the matter shall be entitled to a hearing before the director to contest the action. The person shall file with the director, within fifteen (15) days after receipt of written notice of the action issued by the director, or receipt of actual notice, a written petition stating the grounds for contesting the action by the director and requesting a hearing. See section 42-1701A(3), Idaho Code. **Note: The request must be received by the Department within this fifteen (15) day period.**

APPEAL OF FINAL ORDER TO DISTRICT COURT

Pursuant to sections 67-5270 and 67-5272, Idaho Code, any party aggrieved by a final order or orders previously issued in a matter before the department may appeal the final order and all previously issued orders in the matter to district court by filing a petition in the district court of the county in which:

- i. A hearing was held,
- ii. The final agency action was taken,
- iii. The party seeking review of the order resides, or
- iv. The real property or personal property that was the subject of the agency action is located.

The appeal must be filed within twenty-eight (28) days of: a) the service date of the final order, b) the service date of an order denying petition for reconsideration, or c) the failure within twenty-one (21) days to grant or deny a petition for reconsideration, whichever is later. See section 67-5273, Idaho Code. The filing of an appeal to district court does not in itself stay the effectiveness or enforcement of the order under appeal.
