**FINAL ORDER CURTAILING
GROUND WATER RIGHTS
JUNIOR TO OCTOBER 11, 1900**

The Director of the Idaho Department of Water Resources (“Department”) finds, concludes, and orders as follows:

FINDINGS OF FACT

1. On July 19, 2023, the Director issued the *Sixth Final Order Regarding Methodology for Determining Material Injury to Reasonable In-Season Demand and Reasonable Carryover* (“*Methodology Order*”).¹ The *Methodology Order* established nine steps for determining material injury to members of the Surface Water Coalition (“SWC”).²

2. On April 16, 2025, the Director issued his *Final Order Regarding April 2025 Forecast Supply (Methodology Steps 1–3)* (“*April Forecast Supply Order*”). The *April Forecast Supply Order* predicted an in-season demand shortfall (“IDS”) to the SWC of 63,000 acre-feet for the 2025 irrigation season. *April Forecast Supply Order*, at 3. At that time, the only member of the SWC predicted to experience material injury during the 2025 irrigation season was Twin Falls Canal Company (“TFCC”). *Id.* at 3–4.

3. As a result, the Director ordered that:

On or before May 1, 2025, ground water users holding consumptive water rights bearing priority dates junior to August 28, 1955, within the Eastern Snake Plain Aquifer area of common ground water supply [(“ESPA ACGWS”)] shall establish, to the satisfaction of the Director, that they can mitigate for their proportionate

¹ Shortly after the *Methodology Order* was issued, the Idaho Ground Water Appropriators, Inc. (“IGWA”) and certain Idaho cities filed petitions for judicial review in Ada County (Nos. CV01-23-13173 and CV01-23-13238). IGWA’s petition for judicial review is stayed until December 31, 2027. The cities’ petition for judicial review is pending before the Idaho Supreme Court. The filing of a petition for judicial review does not stay the effectiveness of an order. I.C. § 67-5274. No party to the judicial review proceedings has requested a stay of the *Methodology Order*.

² The SWC is comprised of A&B Irrigation District, American Falls Reservoir District #2, Burley Irrigation District, Milner Irrigation District, Minidoka Irrigation District, North Side Canal Company, and Twin Falls Canal Company.

share of the predicted April IDS of 63,000 acre-feet in accordance with an approved mitigation plan. If a junior ground water user cannot establish, to the satisfaction of the Director, that they can mitigate for their proportionate share of the predicted April IDS in accordance with an approved mitigation plan, the Director will issue an order curtailing the junior-priority ground water user.

April Forecast Supply Order, at 6.

4. On May 16, 2025, the Director issued a *Final Order Curtailing Ground Water Rights Junior to August 28, 1955* (“*Curtailment Order*”). The Director ordered that:

[E]ffective May 31, 2025, ground water users holding water rights bearing priority dates junior to August 28, 1955, within the ESPA ACGWS, and listed in Attachment A to this order, shall curtail/refrain from diversion and use of ground water pursuant to those water rights unless notified by the Department that the order of curtailment has been modified or rescinded as to their water rights.

Curtailment Order, at 4.

5. On July 10, 2025, the Director issued the *Order Revising April 2025 Forecast Supply and Continuing May 16, 2025 Curtailment Order (Methodology Steps 5 & 6)* (“*July As-Applied Order*”), which applied steps 5 and 6 of the *Methodology Order*. The Director predicted a revised IDS of 75,300 acre-feet. *July As-Applied Order*, at 8. Once again, he found TFCC to be the only member of the SWC predicted to experience material injury during the 2025 irrigation season, with an estimated Time of Need of August 28, 2025. *Id.* at 8–9.

6. Consequently, the Director ordered that by “July 24, 2025, ground water users holding consumptive water rights bearing priority dates junior to October 11, 1900, within the [ESPA ACGWS] shall establish, to the satisfaction of the Director, that they can mitigate for their proportionate share of the predicted IDS of 75,300 acre-feet in accordance with an approved mitigation plan.” *Id.* at 12. He ordered that if such a junior ground water user cannot establish that they can mitigate for their proportionate share of the updated predicted IDS “in accordance with an approved mitigation plan, the Director will issue an order curtailing the junior-priority ground water user.” *Id.* Additionally, the Director ordered “that the May 16, 2025 *Curtailment Order* remains in full force and effect.” *Id.*

7. There are currently five approved mitigation plans in place responding to the SWC delivery call:

- (1) Docket No. CM-MP-2010-001 for the benefit of the Southwest Irrigation District and Goose Creek Irrigation District (collectively, “SWID”);
- (2) Docket No. CM-MP-2019-001 for the benefit of certain cities commonly referred to as the “Coalition of Cities”;
- (3) Docket No. CM-MP-2015-003 for the benefit of the A&B Irrigation District (“A&B”);

- (4) Docket No. CM-MP-2007-001 for the benefit of certain entities commonly referred to as the “Water Mitigation Coalition”; and
- (5) Docket No. CM-MP-2024-003 for the benefit of certain ground water districts commonly referred to as the “Ground Water Districts.”

8. In both the *April Forecast Supply Order* and *July As-Applied Order*, the Director concluded that due to the nature of the approved mitigation plans for SWID, the Coalition of Cities, the Water Mitigation Coalition, and the Ground Water Districts, these entities do not need to establish they can mitigate for their proportionate share of the predicted IDS. *April Forecast Supply Order*, at 5 n.8; *July As-Applied Order*, at 11 n.6.

9. However, in the *July As-Applied Order* the Director concluded that A&B must mitigate for its proportionate share of the predicted July IDS of 75,300 acre-feet and determined that A&B’s proportionate share is 5,039 acre-feet. *July As-Applied Order*, at 11 n.6. Although, he did note that in response to the *April Forecast Supply Order*, A&B previously demonstrated that it “already secured 164 acre-feet of storage water for the 2025 irrigation season.” *Id.*

10. On July 24, 2025, A&B and the other members of the SWC submitted a *Joint Motion for Order Approving 2025 Stipulation* (“*Joint Motion*”). The motion explains that A&B and the other members of the SWC entered into a stipulation, referred to as the “*2025 Stipulation*,” to “define A&B’s mitigation obligation for the 2025 irrigation season.” *Joint Motion*, at 2. In the stipulation, which is included as Attachment A to the *Joint Motion*, A&B proposes to continue its ground water conversions projects and deliver 1,252 acre-feet of storage water to TFCC (the injured SWC member) in accordance with its approved mitigation plan. *2025 Stipulation*, at 2. A&B and the other members of the SWC request the Director approve the *2025 Stipulation* as “stipulated compliance with [A&B’s] approved mitigation plan for the 2025 irrigation season.” *Joint Motion*, at 2. In an order issued concurrently with this order, the Director issued his *Order Approving 2025 Stipulation as Compliance with Approved Mitigation Plan*.

CONCLUSIONS OF LAW

1. Idaho Code § 42-602 authorizes the Director to supervise water distribution within water districts:

The director of the department of water resources shall have direction and control of the distribution of water from all natural water sources within a water district to the canals, ditches, pumps and other facilities diverting therefrom. Distribution of water within water districts created pursuant to section 42-604, Idaho Code, shall be accomplished by watermasters as provided in this chapter and supervised by the director. The director of the department of water resources shall distribute water in water districts in accordance with the prior appropriation doctrine. The provisions of chapter 6, title 42, Idaho Code, shall apply only to distribution of water within a water district.

2. As explained above, by July 24, 2025, ground water users with consumptive water rights “junior to October 11, 1900, within the [ESPA ACGWS]” had to “establish, to the

satisfaction of the Director, that they can mitigate for their proportionate share of the predicted IDS of 75,300 acre-feet in accordance with an approved mitigation plan.” *July As-Applied Order*, at 12. If a junior ground water user does not establish that they can mitigate for their proportionate share of the predicted July IDS “in accordance with an approved mitigation plan” the ground water user will be subject to this “order curtailing the junior-priority ground water user.” *Id.*

3. Due to the nature of the approved mitigation plans for SWID, the Coalition of Cities, the Water Mitigation Coalition, and the Ground Water Districts, these entities do not need to establish that they can mitigate for their proportionate share of the predicted July IDS. Junior ground water users entitled to the protection of SWID, the Coalition of Cities, the Water Mitigation Coalition, and the Ground Water Districts mitigation plans continue to not be subject to curtailment during the 2025 irrigation season.

4. Under a separate order, the Director approved the *2025 Stipulation* between A&B and the other members of the SWC because it is consistent with A&B’s approved mitigation plan in Docket No. CM-MP-2015-003. Accordingly, A&B’s water rights will not be subject to curtailment during the 2025 irrigation season.

5. Consistent with the *July As-Applied Order*, Idaho Code § 42-602, and decisions of the courts, the Director must order curtailment of junior-priority ground water users that have not established they can mitigate in accordance with an approved mitigation plan. Junior-priority ground water users subject to curtailment are listed in the updated Attachments A to this order.

ORDER

Based upon and consistent with the foregoing, IT IS HEREBY ORDERED that effective July 25, 2025, ground water users holding water rights bearing priority dates junior to October 11, 1900, within the ESPA ACGWS, and listed in Attachment A to this order, shall curtail/refrain from diversion and use of ground water pursuant to those water rights unless notified by the Department that the order of curtailment has been modified or rescinded as to their water rights.

IT IS FURTHER ORDERED that holders of ground water rights listed in Attachment A to this order, who were not previously listed in Attachment A to the May 16, 2025 *Curtailment Order*, may seek to participate in an approved mitigation plan through a ground water district and shall have fifteen days from the date of this order to join, solely for mitigation purposes, the ground water district situated nearest the lands to which the water rights are appurtenant. *See* H.B. 737a, 58th Leg., 2d Reg. Sess. (Idaho 2006) (*Act Relating to the Administration of Ground Water Rights Within the Eastern Snake River Plain*); *see also* I.C. § 42-5259. The water rights that have fifteen days to join a ground water district are identified in Attachment A.

IT IS FURTHER ORDERED that watermasters for the water districts within the ESPA ACGWS who regulate ground water are directed to review the water rights listed in Attachment A to this order and begin the curtailment process.

IT IS FURTHER ORDERED that this order shall apply to consumptive ground water rights, including but not limited to, agricultural, commercial, industrial, and municipal uses. This order excludes ground water rights used for *de minimis* domestic purposes where such domestic use is within the limits of the definition set forth in Idaho Code § 42-111 and ground water rights used for *de minimis* stock watering where such stock watering use is within the limits of the definitions set forth in Idaho Code § 42-1401A(11), pursuant to IDAPA 37.03.11.020.11.



Unless the right to a hearing before the Department or the Water Resource Board is otherwise provided by statute, any person aggrieved by any final decision, determination, order or action of the Director, and who has not previously been afforded an opportunity for a hearing on the matter may request a hearing pursuant to Idaho Code § 42-1701A(3). A written petition to the Director contesting this final order and requesting a hearing must be filed with the Department by any aggrieved person **within fifteen (15) days after service of this final order.**
