FINAL ORDER CURTAILING GROUND WATER RIGHTS JUNIOR TO AUGUST 15, 1952

The Director of the Idaho Department of Water Resources ("Department") finds, concludes, and orders as follows:

#### FINDINGS OF FACT

- 1. On July 19, 2023, the Department issued its *Sixth Final Order Regarding Methodology for Determining Material Injury to Reasonable In-Season Demand and Reasonable Carryover* ("*Methodology Order*"). The *Methodology Order* established nine steps for determining material injury to members of the Surface Water Coalition ("SWC"). <sup>1</sup>
- 2. On November 21, 2025, the Director issued the *Final Order Establishing 2025* Reasonable Carryover (Methodology Step 9) ("Step 9 Order"). Therein, the Director concluded there is a 65,824-acre-foot ("AF") volume of material injury to Twin Falls Canal Company's reasonable carryover and a 20,932 AF volume of material injury to AFRD2. Step 9 Order, at 5. The Director concluded no other members of the SWC have a reasonable carryover shortfall. *Id*.
- 3. The Director ordered that within fourteen days of November 21, 2025, "junior ground water users holding consumptive ground water rights within the Eastern Snake Plain Aquifer area of common ground water supply bearing priority dates junior to August 15, 1952, must mitigate for the reasonable carryover shortfall of 86,756 AF in accordance with an approved mitigation plan." *Id.* The Director also ordered that, if such junior ground water users cannot establish that they can mitigate for the reasonable carryover shortfall "in accordance with an approved mitigation plan, the Director will issue an order curtailing the junior-priority ground water use." *Id.*

- 4. There are currently five approved mitigation plans in place responding to the SWC delivery call:<sup>2</sup>
  - (1) Docket No. CM-MP-2007-001 for the benefit of J.R. Simplot Company, Basic American Foods, and ConAgra Foods Packaged Foods Company, Inc., d/b/a Lamb-Weston (collectively, the "Water Mitigation Coalition");
  - (2) Docket No. CM-MP-2010-001 for the benefit of the Southwest Irrigation and Goose Creek Irrigation Districts (collectively, "SWID");
  - (3) Docket No. CM-MP-2015-003 for the benefit of the A&B Irrigation District ("A&B");
  - (4) Docket No. CM-MP-2019-001 for the benefit of certain cities commonly referred to as the "Coalition of Cities," the City of Idaho Falls, and the City of Pocatello (collectively, the "Cities").
  - (5) Docket No. CM-MP-2024-003 for the benefit of Aberdeen-American Falls Ground Water District, Bingham Ground Water District, Bonneville-Jefferson Ground Water District, Carey Valley Ground Water District, Henry's Fork Ground Water District, Jefferson-Clark Ground Water District, Madison Ground Water District, Magic Valley Ground Water District, and North Snake Ground Water District (collectively, the "Ground Water Districts");
- 5. In the *Step 9 Order*, the Director found that due to the nature of the approved mitigation plans for the Water Mitigation Coalition, SWID, the Cities, and the Ground Water Districts, these entities do not need to establish that they can mitigate for their proportionate share of the reasonable carryover shortfall. *Step 9 Order*, at 5 n.10. However, the Director found that due to the nature of A&B's mitigation plan, A&B must establish to the satisfaction of the Director its ability to mitigate for its proportionate share of the reasonable carryover shortfall, which is 457 AF. *Id*.
- 6. In response to the *Step 9 Order's* requirement for A&B to establish how it will mitigate its proportionate share of the reasonable carryover shortfall, A&B submitted *A&B Irrigation District's Request for Hearing/Evidence of Ability to Mitigate* ("*Mitigation Response*"). In the *Mitigation Response*, A&B stated that it does not intend to submit a lease demonstrating that it has secured the required storage for the benefit of the injured SWC members at this time. *Mitigation Response* at 3. A&B acknowledged that this may result in the Director including A&B's junior priority water rights in the list of water rights subject to this curtailment order. *Id*.

#### **CONCLUSIONS OF LAW**

1. Idaho Code § 42-602 authorizes the Director to supervise water distribution within

Because these plans are unapproved, water users may not rely on them for protection from curtailment at this time. In addition, CM-MP-2025-002 (Simplot) is no longer an effective mitigation plan because it was approved only for the 2025 irrigation season.

#### water districts:

The director of the department of water resources shall have direction and control of the distribution of water from all natural water sources within a water district to the canals, ditches, pumps and other facilities diverting therefrom. Distribution of water within water districts created pursuant to section 42-604, Idaho Code, shall be accomplished by watermasters as provided in this chapter and supervised by the director.

The director of the department of water resources shall distribute water in water districts in accordance with the prior appropriation doctrine. The provisions of chapter 6, title 42, Idaho Code, shall apply only to distribution of water within a water district.

- 2. As explained above, within fourteen days of November 21, 2025, "junior ground water users holding consumptive ground water rights within the Eastern Snake Plain Aquifer area of common ground water supply bearing priority dates junior to August 15, 1952, must mitigate for the reasonable carryover shortfall of 86,756 AF in accordance with an approved mitigation plan." Step 9 Order, at 5. If a junior ground water user does not establish that they can mitigate for the reasonable carryover shortfall in accordance with an approved mitigation plan, the ground water user will be subject to this "order curtailing the junior-priority ground water use." Id.
- 3. Due to the nature of the approved mitigation plans for the Water Mitigation Coalition, SWID, the Cities, and the Ground Water Districts, these entities do not need to establish that they can mitigate for their proportionate share of the reasonable carryover shortfall. Junior ground water users entitled to protection under the Water Mitigation Coalition's, SWID's, the Cities', or the Ground Water Districts' approved mitigation plans will not be subject to curtailment related to the reasonable carryover shortfall.
- 4. A&B has failed to provide timely documentation that it has adequately secured the storage water necessary to mitigate fully for its obligation under its approved mitigation plan. Accordingly, to ensure that A&B's ground water rights junior to August 15, 1952, are curtailed during the 2026 irrigation season, the Director will include A&B's water rights junior to August 15, 1952, on the curtailment list in Attachment A to this order.
- 5. The Director concludes that junior-priority ground water users who have not established that they can mitigate for the reasonable carryover shortfall in accordance with an approved mitigation plan should be curtailed. Junior-priority ground water users subject to curtailment are listed in Attachment A to this order.<sup>3</sup>

The administration of the newly included area of the Little Lost River Tributary Basin will be phased-in to the SWC delivery call proceeding and junior ground water rights newly included in the ESPA ACGWS are not included in the attached curtailment list. The Director anticipates issuing additional orders related to the expansion of the ESPA ACGWS. After that, the Director will issue an order addressing how the water rights in the newly expanded ESPA ACGWS will be

#### ORDER

Based upon and consistent with the foregoing, IT IS HEREBY ORDERED that effective December 8, 2025, ground water users holding water rights bearing priority dates junior to August 15, 1952, within the Eastern Snake Plain Aquifer area of common ground water supply ("ESPA ACGWS") and listed in Attachment A to this order, shall curtail/refrain from diversion and use of ground water pursuant to those water rights unless notified by the Department that the curtailment order has been modified or rescinded as to their water rights.

IT IS FURTHER ORDERED that holders of ground water rights listed in Attachment A to this order, who were not previously listed in Attachment A to the July 25, 2025 Curtailment Order, may seek to participate in an approved mitigation plan through a ground water district and shall have fifteen days from the date of this order to join, solely for mitigation purposes, the ground water district situated nearest the lands to which the water rights are appurtenant. See H.B. 737a, 58th Leg., 2d Reg. Sess. (Idaho 2006) (Act Relating to the Administration of Ground Water Rights Within the Eastern Snake River Plain); see also I.C. § 42-5259. The water rights that have fifteen days to join a ground water district are identified in Attachment A.

IT IS FURTHER ORDERED that watermasters for the water districts within the ESPA ACGWS who regulate ground water are directed to review the water rights listed in Attachment A to this order and begin the curtailment process.

IT IS FURTHER ORDERED that this order applies to consumptive ground water rights, including but not limited to, agricultural, commercial, industrial, and municipal uses. This order excludes ground water rights used for *de minimis* domestic purposes where such domestic use is within the limits of the definition set forth in Idaho Code § 42-111 and ground water rights used for *de minimis* stock watering where such stock watering use is within the limits of the definitions set forth in Idaho Code § 42-1401A(11), pursuant to IDAPA 37.03.11.020.11.

# EXPLANATORY INFORMATION TO ACCOMPANY A FINAL ORDER

(To be used in connection with actions when a hearing was **not** held)

(Required by Rule of Procedure 740.02)

The accompanying order is a "**Final Order**" issued by the department pursuant to section 67-5246. Idaho Code.

#### PETITION FOR RECONSIDERATION

Any party may file a petition for reconsideration of a final order within fourteen (14) days of the service date of this order as shown on the certificate of service. **Note: The petition must be** <u>received</u> by the Department within this fourteen (14) day period. The department will act on a petition for reconsideration within twenty-one (21) days of its receipt, or the petition will be considered denied by operation of law. See section 67-5246(4), Idaho Code.

#### REQUEST FOR HEARING

Unless the right to a hearing before the director or the water resource board is otherwise provided by statute, any person who is aggrieved by the action of the director, and who has not previously been afforded an opportunity for a hearing on the matter shall be entitled to a hearing before the director to contest the action. The person shall file with the director, within fifteen (15) days after receipt of written notice of the action issued by the director, or receipt of actual notice, a written petition stating the grounds for contesting the action by the director and requesting a hearing. See section 42-1701A(3), Idaho Code. **Note: The request must be** received by the Department within this fifteen (15) day period.
