**ORDER PHASING IN  
ADMINISTRATION OF GROUND  
WATER RIGHTS RECENTLY  
INCLUDED IN THE ESPA  
ACGWS**

**BACKGROUND**

The Eastern Snake Plain Aquifer Area of Common Ground Water Supply (“ESPA ACGWS”) is the administrative boundary for the Surface Water Coalition (“SWC”) delivery call proceeding (Docket No. CM-DC-2010-001), the proceeding in which this order is being issued.

On November 26, 2025, the Director of the Idaho Department of Water Resources (“Department”) expanded the SPA ACGWS to include the portion of the Little Lost River basin that was not already included within the SPA ACGWS. *See Order Expanding the Eastern Snake Plain Aquifer Area of Common Ground Water Supply to Include the Little Lost River Tributary Basin* (Nov. 26, 2025).

On December 15, 2025, the Director expanded the SPA ACGWS to include the Raft River Basin. *See Order Expanding the Eastern Snake Plain Aquifer Area of Common Ground Water Supply to Include the Raft River Tributary Basin* (Dec. 15, 2025).

On January 13, 2026, the Director expanded the SPA ACGWS to include the portion of the Big Lost River Basin that was not already included within the SPA ACGWS. *See Order Expanding the Eastern Snake Plain Aquifer Area of Common Ground Water Supply to Include the Big Lost River Tributary Basin* (Jan. 13, 2026).

This order is necessary because the expansion of the SPA ACGWS subjects previously unadministered ground water rights to administration in the SWC delivery call proceeding. Furthermore, there is currently a curtailment order in effect in the SWC delivery call proceeding, curtailing ground water rights junior to August 15, 1952. *See Final Order Curtailing Ground Water Rights Junior to August 15, 1952* (Dec. 8, 2025).

The Director must decide how to address the inclusion of these ground water rights into the SPA ACGWS and decide whether the administration of the newly included junior-priority ground water rights should be phased-in pursuant to Rule 40.01.a of the Rules for Conjunctive Management of Surface and Ground Water Resources (“CM Rule”) (IDAPA 37.03.11).

## ANALYSIS

When the Director issued the orders expanding the ESPA ACGWS, 1,005 ground water rights within the expanded area of administration not previously subject to administration were brought into the SWC delivery call and immediately became subject to administration. These water rights are listed in Attachment A to this order.

As discussed above, there is currently a curtailment order in effect in the SWC delivery call proceeding, curtailing ground water rights junior to August 15, 1952. Many of the previously unadministered ground water rights are not currently participating in a Department-approved mitigation plan. Therefore, the newly included water rights junior to August 15, 1952, not currently participating in an approved mitigation plan are subject to immediate curtailment under the current curtailment order. CM Rule 40.

Pursuant to CM Rule 40.01.a, the Director may, by order, phase-in regulation of junior-priority ground water diversions where material injury is delayed or long range to lessen the economic impact of immediate and complete curtailment.

The Director finds that the material injury caused by the diversion and use of water under these newly included ground water rights is delayed or long range. The Director also finds that the economic impact of immediate and complete curtailment would be severe. The Department has observed that the time required to submit, review, publish, and issue an order regarding a mitigation plan can vary greatly. Approval of an unprotested mitigation plan can occur as quickly as several months. Whereas a protested mitigation plan that is subject to a contested case proceeding and appeal process can take more than a year to resolve.

The Director concludes that priority administration of these newly included ground water rights should be phased-in to provide the affected water users a reasonable time to implement a mitigation plan “to lessen the economic impact of immediate and complete curtailment.” CM Rule 40.01.a. Accordingly, the newly included water rights listed in Attachment A will not be subject to administration in the SWC delivery call sooner than April 1, 2027. All water rights that are newly included in the ESPA ACGWS are on notice that they could be subject to a curtailment order in approximately 14 months.

## ORDER

Based upon and consistent with the foregoing, IT IS HEREBY ORDERED that ground water rights newly included in the ESPA ACGWS and listed in Attachment A to this order will be phased-in to the SWC delivery call proceeding and will not be subject to administration sooner than April 1, 2027.



## **EXPLANATORY INFORMATION TO ACCOMPANY A FINAL ORDER**

(To be used in connection with actions when a hearing was **not** held)

(Required by Rule of Procedure 740.02)

The accompanying order is a "Final Order" issued by the department pursuant to section 67-5246, Idaho Code.

### **PETITION FOR RECONSIDERATION**

Any party may file a petition for reconsideration of a final order within fourteen (14) days of the service date of this order as shown on the certificate of service. **Note: The petition must be received by the Department within this fourteen (14) day period.** The department will act on a petition for reconsideration within twenty-one (21) days of its receipt, or the petition will be considered denied by operation of law. See section 67-5246(4), Idaho Code.

### **REQUEST FOR HEARING**

Unless the right to a hearing before the director or the water resource board is otherwise provided by statute, any person who is aggrieved by the action of the director, and who has not previously been afforded an opportunity for a hearing on the matter shall be entitled to a hearing before the director to contest the action. The person shall file with the director, within fifteen (15) days after receipt of written notice of the action issued by the director, or receipt of actual notice, a written petition stating the grounds for contesting the action by the director and requesting a hearing. See section 42-1701A(3), Idaho Code. **Note: The request must be received by the Department within this fifteen (15) day period.**
