This email is provided in response to the Idaho Ground Water Appropriators, Inc.'s request that the Department provide the parties the modeling files used in the *Final Order Regarding Rangen, Inc.'s Petition for Delivery Call; Curtailing Ground Water Rights Junior to July 13, 1962*, dated January 29, 2014. The modeling files have been posted to the Department's FTP site at

The files posted were used to generate the data in Findings of Fact 108 through 110, Conclusions of Law 55 and 56, and the third paragraph on page 42. The data in Finding of Fact 107 were generated by multiplying the benefits to the total spring complex in Finding of Fact 106 by 63% to calculate the benefits to Curren Tunnel.
