
CHRISTIAN PETRICH, being first duly sworn deposes and says:

1. I have been employed by the Coalition of Cities to assist them in the above listed matters and am familiar with the pleadings and documents filed in this case.
2. I have investigated and am familiar with the water rights held by all members of the Coalition of Cities.

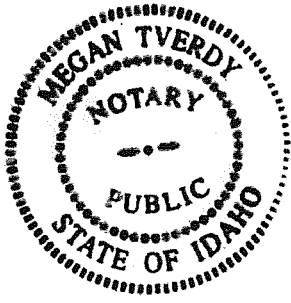
3. The depletive amount that will occur at the Curren Tunnel as a result of depletions by Coalition cities Carey, Heyburn, and Richfield under water rights with priority dates on or junior to August 12, 1973 is 0.001 cfs (0.45 gpm) during the first year of pumping and 0.015 cfs (6.73 gpm) under steady-state conditions. Withdrawals for consumptive uses by the remaining Coalition cities (Bliss, Burley, Declo, Dietrich, Gooding, Hazelton, Jerome, Paul, Rupert, Shoshone, and Wendell) can be allocated to water rights with priority dates senior to August 12, 1973.
4. The 1,500 acre-feet of recharge at the Gooding Recharge Site proposed for 2015 will exceed the aggregate depletive amount under the Coalition of Cities' junior water rights (approximately 836 AFA). The first-year benefit of recharge at the Gooding Recharge Site is simulated to be 0.006 cfs (2.69 gpm). The simulated recharge benefit is approximately six times the 0.001-cfs (0.45 gpm) first-year impact at the Rangen facility from Coalition cities' depletions under post-August 12, 1973 water rights.
5. The Gooding Recharge Site is substantially closer to the Rangen facility than the location of depletions at Carey, Heyburn, and Richfield. Proximity of the recharge site to the Rangen facility, and recharge in excess of aggregate post-August 12, 1973 Coalition depletions, means that the benefits of Coalition cities' recharge will quickly exceed that of Coalition cities' depletions during the first year.
6. Groundwater withdrawals for cities and industrial areas are represented in the Eastern Snake Plain Aquifer Model (ESPAM 2.1) calibration runs (IDWR, 2013). However, curtailment of municipal use was not simulated in the curtailment simulations made in preparation of the Rangen orders (Allan Wylie, personal communication, April 18, 2014 and July 18, 2014). Thus, any benefits accruing from either curtailment of municipal rights or mitigation in lieu of curtailment of municipal rights will provide benefits to the Rangen facility over and above those calculated by IDWR as necessary to satisfy the Rangen delivery call.
7. The above-described conclusions are based on an analysis of Coalition cities' water rights, analysis of consumptive and non-consumptive use by Coalition members, and on simulation of depletive impacts using the transient, superposition, 150-year version of ESPAM 2.1.
