CONFERENCE

On April 17, 2013, James C. Scheff and Trudie G. Sheff filed a *Petition for Delivery Call for Expedited Proceeding and Request for Emergency Order* ("Petition"). The petition requests that the Department regulate the use of water pursuant to Water Right 61-12112 to protect the Scheffs' ability to divert water pursuant to Water Right 61-11833.


Candice M. Mc Hugh filed a *Notice of Appearance* on behalf of the owners of Water Right 61-12112 -- Cardon Hiatt Investments LLC, SMT Investors Limited Partnership, Viel Gluck Limited Partnership, Ben Fatt Limited Partnership, and Far Marel LLC ("Respondents").

On Monday, May 20, 2013, the Department hosted an informal pre-hearing conference attended by James C. Scheff and his representatives and by representatives of the Respondents. At the conference, the parties agreed to attempt resolution of this matter by continuing informal discussions without Department participation for the time being.

In order to determine the progress of the informal discussions, the Department will hold a status conference by telephone on **June 19, 2013, at 10:00 a.m.** The parties shall participate by calling 215-446-0193 and entering participant code 771162.

The Department will conduct the conference in a manner that satisfies the accessibility requirements of the Americans with Disabilities Act. Anyone requiring special accommodations in order to attend, participate in, or understand the status conference, should notify the Department at least five (5) days prior to the conference.
