Idaho Ground Water Appropriators, Inc. (IGWA), acting for and on behalf of its members, hereby petitions to intervene in this matter pursuant to Idaho Department of Water Resources (IDWR) Rules of Procedure 156 and 350 through 354.¹

Rule 156 defines “Intervenors” as “[p]ersons, not applicants or claimants, appellants, complainants, respondents or protestants to a proceeding, who are permitted to participate as parties pursuant to Rule 350 through 354” Rule 350 states: “Persons not applicants or claimants or appellants, petitioners, complainants, protestants, or respondents to a proceed-

ing who claim a direct and substantial interest in the proceeding may petition for an order from the presiding officer granting intervention to become a party, if a formal hearing is required by statute to be held in the proceeding.” A petition to intervene shall be granted if the petition “shows direct and substantial interest in any part of the subject matter of a proceeding and does not unduly broaden the issues, . . . unless the applicant’s interest is adequately represented by existing parties.”²

On May 28, 2014, ARK Fisheries, Inc., filed a Petition for Delivery Call (“Petition”) before the Department alleging that ARK Fisheries, Inc.’s decreed water rights have suffered and will continue to suffer material injury as a result of junior-priority ground water rights in the Eastern Snake Plain Aquifer Area. The Petition asks the Director to order curtailment of diversions under water rights junior to ARK Fisheries, Inc.’s water right no. 36-07278.

On June 19, 2014, Dan Lee and Dadhri Lee, filed a Petition for Delivery Call (“Petition”) before the Department alleging that Dan Lee and Dadhri Lee’s decreed water rights have suffered and will continue to suffer material injury as a result of junior-priority ground water rights in the Eastern Snake Plain Aquifer Area. The Petition asks the Director to order curtailment of diversions under water rights junior to Dan Lee and Dadhri Lee’s water right no. 36-00124A and 36-07315.

IGWA represents Ground Water Districts whose members include hundreds of irrigators, municipalities, and commercial and industrial entities who own water rights that divert from the Eastern Snake Plain Aquifer (ESPA) that are exposed to curtailment under the Petition. As such, IGWA and its members have a direct and substantial interest the Petition. Therefore, IGWA requests an order granting it intervention in this matter.
