On August 11, 2014, the Director (“Director”) of the Idaho Department of Water Resources (“Department”) held a status conference with the parties regarding the above-referenced delivery calls. At this status conference, petitioners ARK Fisheries, Inc. and Dan and Dadrhi Lee; respondent City of Pocatello; and intervenor Idaho Ground Water Appropriators, Inc., collectively requested a delay of formal proceedings in this matter and stipulated to the setting of a continued status conference in January 2015 in order to obtain water modeling information and attempt to resolve delivery calls filed by ARK Fisheries, Inc. and Dan and Dadrhi Lee.


