**SECOND NOTICE OF CONTINUED  
PREHEARING CONFERENCE**

On January 31, 2022, the Idaho Department of Water Resources (“Department”) held a continued prehearing conference via videoconference in the above-referenced matter. All parties and their representatives were present and participated via Zoom. During the continued prehearing conference, Michael and Lori Beer (Petitioners) agreed to amend their petition to describe an “area of common ground water supply” (ACGWS) consistent with IDAPA 37.03.11—Conjunctive Management of Surface and Ground Water Resources, Rule 30.01.d. Depending on the description of the ACGWS, IDWR may issue general notice of this contested case to ensure full and complete participation by any affected water user, consistent with IDAPA 37.03.11, Rule 30.02. To ensure sufficient time for the Petitioners to amend their petition and for the Department to notice the contested case if needed, the parties agreed to continue the prehearing conference on April 14, 2022.

The Department hereby notifies the parties that a continued prehearing conference will be held in the above-captioned matter on **April 14, 2022, at 1:30 p.m. (MST)**. The conference meeting will be held via Zoom virtual conferencing. All parties must be present at the continued prehearing conference. The parties shall come prepared to identify the issues to be addressed at the hearing and to establish the hearing schedule.


