On February 3, 2010, Unit A filed its Opposition to Stipulation and Joint Motion for Approval of A&B Irrigation District's Rule 43 Mitigation Plan ("Opposition"). Regarding the Joint Stipulation, the Department has not heard from the Ground Water Users or Pocatello.

On February 11, 2010, the parties shall appear either in person or by telephone, before the Director, at the Department at 10:30 a.m. for a status conference in the Director's conference room.
