Pocatello does not object in concept to the Stipulation and Joint Motion for Approval of A&B Irrigation District's Rule 43 Mitigation Plan ("Joint Stipulation") received February 1, 2010. However, even if the Joint Stipulation is approved by the Director, there remain mixed issues of law and fact in this case: how will the Department provide credit for mitigation water where multiple mitigation plans propose to address the same alleged shortage, and specifically, how will the Department calculate and assign such mitigation credit to prevent over-mitigation? If the Joint Stipulation is to be approved by the Director, the Director must then address these remaining questions of law and fact that are common to the mitigation plans before the Department.
