On December 22, 2009, the interim director of the Idaho Department of Water Resources issued an *Order Granting Motion to Limit Scope of Hearing; Denying Motion to Strike Clear Springs' Protest; and Scheduling Order* ("Order Limiting Scope of Hearing"). On February 9, 2010, Blue Lakes Trout Farm, Inc. ("Blue Lakes") petitioned the interim director to reconsider his decision to limit the scope of the hearing. On February 23, 2010, the North Snake Ground Water District, the Magic Valley Ground Water District, and the City of Pocatello filed responses to Blue Lakes' petition for reconsideration.

Having reconsidered the petition for reconsideration, the documents accompanying the petition, and the responses, the interim director finds the petition for reconsideration and supporting arguments to be unpersuasive, and reaffirms the previous decision.
