6. Basis of protest:

LSRARD generally is not opposed to recharge as part of a mitigation plan and encourages development of recharge sites in areas that will provide benefit to water users while not compromising existing water rights or water resources of the state. LSRARD does not believe, however, that the Director can approve recharge at the site proposed in this mitigation plan because the plan does not meet various evaluation criteria under Conjunctive Management Rule 43 (IDAPA 37.03.11.43.03. a, c & j). For example, the applicant has not documented that an IDEQ-approved water quality monitoring plan is in place that is specific to the proposed recharge site to protect water users, the environment, current and future local drinking water sources, and water resources of the state (IDAPA 58.01.16.600). The applicant has not documented that they have obtained an IDEQ-approved reuse permit to use treated municipal wastewater as the proposed contingency source of recharge water at this site (IDAPA 58.01.17).

(2) LSRARD reserves the right to modify this protest as other information becomes available through discovery or at hearing.

7. What would resolve the protest:

(1) Provide documentation that a water quality monitoring plan has been approved by IDEQ and will be in place before the proposed site is used for managed recharge activities using applicant's canal company water shares, including activities intended to supply water for a mitigation plan. Refer to IDAPA 58.01.16.600 and IDEQ's "Guidance for Developing a Ground Water Quality Monitoring Program for Managed Recharge Projects by Land Application" (written 2006; revised 2010). Designate as part of the mitigation plan the party who will be responsible for conducting water quality sample collection, monitoring and reporting, and the party who will pay for water quality analyses, monitoring and reporting.

and

(2) Remove from the mitigation plan any reference to using treated wastewater from any municipal system as the contingency recharge water source unless an IDEQ-approved permit has been issued for its use at the proposed site under IDAPA 58.01.17.

and

(3) To support both resolution items (1) and (2), provide documentation through the completion of an IDWR-monitored dye tracer study that recharge at the proposed site will not adversely affect local domestic and drinking water sources or beneficial uses of existing or future water rights in the flow path of the recharge water.
