**ORDER GRANTING IGWA'S MOTION TO
VACATE HEARING AND NOTICE OF
THIRD STATUS CONFERENCE**

On September 4, 2014, the Idaho Department of Water Resources ("Department") issued an *Order Granting IGWA's Motion to Continue Hearing; Notice of Hearing* which rescheduled the hearing to be held in the above-captioned matter to October 20-21, 2014.

On September 25, 2014, the Department issued a *Second Notice of Status Conference* which set a status conference for October 3, 2014, for the purpose of hearing preparation.

On September 25, 2014, IGWA filed *IGWA's Motion to Vacate Hearing* in order to delay the October 20-21, 2014, hearing until decisions are entered on IGWA's pending Fourth Mitigation Plan and pending Application for Permit 36-16976.

During the October 3, 2014, status conference the parties reached an agreement to postpone the October 20-21, 2014 hearing. Dates will be provided to the parties by IGWA's attorney, Thomas J. Budge, and alternative hearing date(s) will be determined and a third notice of hearing will be issued according to the dates the parties choose. The Department should grant IGWA's September 25, 2014, motion to vacate.

Also, during the October 3, 2014, status conference IGWA requested a status conference be held on October 21, 2014, at 10 a.m.

ORDER

IT IS HEREBY ORDERED that the hearing dates of October 20 & 21, 2014, are vacated.

The status conference will be conducted in a facility which meets the accessibility requirements of the Americans with Disabilities Act.
