BACKGROUND

On February 23, 2024, the Director issued a *Notice of Prehearing Conference; Order Appointing Hearing Officer* setting a prehearing conference for March 11, 2024. On March 5, 2024, A&B Irrigation District and the Coalition of Cities filed a *Stipulated Motion to Vacate and Reschedule Prehearing Conference* (“*Motion*”) with the Department. The parties request the March 11, 2024 prehearing conference be vacated and rescheduled for March 22, 2024, at 11:00 a.m. *Motion* at 1. On the grounds that it is stipulated to by all parties, the hearing officer will grant the *Motion*.

IT IS HEREBY ORDERED that the parties’ *Stipulated Motion to Vacate and Reschedule Prehearing Conference* is hereby GRANTED.


