**NOTICE OF CONTINUED
PREHEARING CONFERENCE**

BACKGROUND

On December 18, 2023, Madison Ground Water District and Henry’s Fork Ground Water District submitted a *Petition for Approval of Madison Ground Water District and Henry’s Fork Ground Water District’s Storage Water Mitigation Plan for the Surface Water Coalition (“Proposed Mitigation Plan”)* with the Department. The *Proposed Mitigation Plan* was protested by A&B Irrigation District, Burley Irrigation District, Milner Irrigation District, North Side Canal Company, Twin Falls Canal Company, American Falls Reservoir District #2, and Minidoka Irrigation District (collectively, the “Surface Water Coalition”), American Falls-Aberdeen Ground Water District, the City of Pocatello, and the cities of Bliss, Burley, Carey, Declo, Dietrich, Gooding, Hazelton, Heyburn, Jerome, Paul, Richfield, Rupert, Shoshone, and Wendell (collectively, the “Coalition of Cities”).

On April 8, 2024, Hearing Officer Schroeder held a prehearing conference in the above referenced matter. All parties were represented by counsel. The parties agreed to a continued prehearing conference on June 24, 2024.




