ORDER GRANTING IN PART AND DENYING IN PART STIPULATED MOTION TO VACATE AND RESCHEDULE PREHEARING CONFERENCE

NOTICE OF PREHEARING CONFERENCE

On February 23, 2024, the Director issued a *Notice of Prehearing Conference; Order Appointing Hearing Officer* setting a prehearing conference for March 11, 2024. On February 27, 2024, Jefferson Clark Ground Water District, the Surface Water Coalition, American Falls-Aberdeen Ground Water District, the City of Pocatello, and the Coalition of Cities filed a *Stipulated Motion to Vacate and Reschedule Prehearing Conference* ("*Motion*") with the Department. The parties request the March 11, 2024 prehearing conference be vacated and rescheduled "within 10-14 business days (no earlier than April 5, 2024) following a decision from the Hearing Officer (Justice Roger Burdick) in contested case no. CM-MP-2016-001. . . . If this motion is granted counsel will coordinate with IDWR staff regarding re-scheduling the prehearing conference." *Motion* at 2.

On the grounds that it is stipulated to by all parties, the hearing officer will grant the parties' request to vacate the prehearing conference presently set for March 11, 2024. In the interest of ensuring the contested case advances without unnecessary delay, the hearing officer will deny the parties' request to coordinate with the Department to reschedule the prehearing conference at a later date and will instead reschedule the prehearing conference for a date certain after April 5, 2024. If a decision on the pertinent issues in contested case No. CM-MP-2016-001 is not issued at least one week prior to the rescheduled prehearing conference, the hearing officer will entertain another motion to vacate and reschedule the prehearing conference at that time.

#### **ORDER**

IT IS HEREBY ORDERED that the parties' *Stipulated Motion to Vacate and Reschedule Prehearing Conference* is hereby GRANTED IN PART and DENIED IN PART.

IT IS FURTHER ORDERED that the prehearing conference presently set for March 11, 2024, is hereby VACATED.
