**NOTICE OF CONTINUED
PREHEARING CONFERENCE**

BACKGROUND

On May 7, 2024, Falls Irrigation District submitted *Falls Irrigation District's Rule 43 Mitigation Plan* ("Proposed Mitigation Plan") to the Idaho Department of Water Resources ("Department"), pursuant to Rule 43 of the Department's Rules for Conjunctive Management of Surface and Ground Water Resources (IDAPA 37.03.11.043). Idaho Ground Water Appropriators, Inc., protested the *Proposed Mitigation Plan*.

On July 30, 2024, Hearing Officer Schroeder held a prehearing conference in the above referenced matter. All parties appeared represented by counsel. The parties requested additional time to discuss a resolution or to at least narrow the issues. Accordingly, the parties asked the Hearing Officer to schedule a continued prehearing conference on October 7, 2024. The Hearing Officer agreed.


