**IN THE MATTER OF PETITION TO

**ORDER GRANTING SURFACE
WATER COALITION'S REQUEST
TO WITHDRAW REQUEST FOR
HEARING**

This matter is before the Director ("Director") of the Idaho Department of Water Resources ("Department") as a result of *Clear Springs Foods, Inc.'s Petition to Amend Rule 50* ("Petition") filed with the Department on November 10, 2010. The Director issued a *Final Order* ("Final Order") on August 29, 2014 denying in part and granting in part the Petition. The Director granted the request to enter into the rulemaking process concerning this rule, but denied the request to amend the rule; instead determining that the rule should be repealed entirely.

On September 12, 2014, several irrigation entities¹ represented by John K. Simpson and W. Kent Fletcher, collectively known as the Surface Water Coalition ("SWC") filed the *Surface Water Coalition's Petition Requesting Hearing* ("Request for Hearing").

On December 4, 2014, John K. Simpson, counsel for the SWC informed counsel for the Department by electronic-mail that the SWC withdraws its Request for Hearing.

ORDER

Based upon and consistent with the foregoing, IT IS HEREBY ORDERED that the Surface Water Coalition's request to withdraw its Request for Hearing is GRANTED.


