GROUND WATER DISTRICT (collectively referred to herein as "Ground Water Districts") through counsel and on behalf of their ground water district members and those ground water users who are non-member participants in the Ground Water Districts' mitigation activities, and hereby provides this Joint Supplemental Replacement Water Plan ("Supplemental Replacement Water Plan") to supplement the North Snake Ground Water District and Magic Valley Ground Water District's Joint Replacement Water Plan for 2007, filed with the Department on April 9, 2007. These two plans will NORTH SNAKE GROUND WATER DISTRICT AND MAGIC VALLEY GROUND WATER DISTRICT JOINT SUPPLEMENTAL REPLACEMENT WATER PLAN Page 1 be referred to collectively herein as the "Joint Replacement Water Plans for 2007." This Supplemental Replacement Water Plan is provided in response to the Idaho Department of Water Resources' June 15, 2007 Orders Curtailing Junior Priority Water Rights (Blue Lakes Delivery Call and Clear Springs, Snake River Farm Delivery Call). These Orders will be referred to herein collectively as the "2007 Curtailment Orders."

I. Reservation of Defenses.

By submitting this Supplemental Replacement Water Plan the Ground Water Districts do not waive and expressly reserve any and all objections and defenses as set forth in any of their prior filings they may have to the 2007 Curtailment Orders and any previous orders.

II. Supplemental Replacement Water Plan Activity.

This Supplemental Replacement Water Plan and the proposed activities are contingent upon approval of the Joint Replacement Water Plans for 2007, resulting in no curtailment of ground water users for the 2007 calendar year.

The Ground Water Districts propose to provide an additional 10,000 acre-feet of water through the North Side Canal Company delivery system for late season recharge. The Idaho Ground Water Appropriators, Inc. ("IGWA") on behalf of its ground water district members has secured an additional 10,000 acre-feet of water for delivery to the North Side Canal Company's point of diversion at Milner Dam after North Side Canal Company stops irrigation deliveries this year. Conveyance of this water through North Side Canal Company is being negotiated. This brings the total amount of water to be conveyed to Wilson Lake or other locations for recharge purposes to 20,000 acre-feet. Delivery of this surface water to Wilson Lake will result in recharge to the aquifer from seepage or conveyance loss through the canal itself and seepage from the lake itself. The water leases that IGWA has entered into for the additional 10,000 acre-feet of water are currently being reviewed and routed for signature. These leases are contingent upon the Director's approval of the Joint Replacement Water Plans for 2007 resulting in no curtailment of ground water users this calendar year. Once the Department has approved the Joint Replacement Water Plans for 2007, resulting in an Order halting any and all curtailment for this calendar year, IGWA will provide fully executed leases to the Department.

Finally, the Ground Water Districts reserve the right to modify or withdraw this Supplemental Replacement Water Plan.

REQUEST FOR RELIEF

The Ground Water Districts request that the Department approve the Joint Replacement Water Plans for 2007 rendering any curtailment unnecessary.
