

NOTICE IS HEREBY GIVEN THAT:

1. The above named Appellant, IDAHO GROUND WATER APPROPRIATORS, INC. ("IGWA" or "Ground Water Users") for and on behalf of its members, appeals against the above named respondents to the Idaho Supreme Court from the District Court's final *Amended Order on Petitions for Rehearing, Order Denying Surface Water Coalition's Motion for Clarification* ("Final Order"), entered in the above entitled action on September 9, 2010, the Honorable John M. Melanson presiding. Unless modified by the Final Order, The Final Order expressly incorporates the District Court's Order on Petition for Judicial Review, entered in the above entitled action on July 24, 2009, the Honorable John M. Melanson presiding.

2. The Appellants have a right to appeal to the Idaho Supreme Court, and the *Amended Order on Petitions for Rehearing, Order Denying Surface Water Coalition's Motion for Clarification* is appealable pursuant to Rule 11(f) of the Idaho Appellate Rules.

3. The Appellants intend to assert the following preliminary issues on appeal, provided this list of issues shall not prevent the appellant from asserting other issues on appeal:

- a. Whether the District Court erred in holding that the Director abused his discretion in determining that Twin Falls Canal Company full supply of water should be based upon 5/8 inch per acre for purpose of calculating any mitigation requirement of ground water users in the under the Conjunctive Management Rules.

- b. Whether the District Court erred in rejecting the Director's determination that any reasonable carry-over obligation should be provided in the season in which the water can be put to beneficial use, not the season before.
- c. Whether the District Court erred in holding that the Director exceeded his authority by refusing to curtail junior ground water users to provide for more than one year of reasonable carry-over storage.
- d. Whether the Court erred in incorporating the *Memorandum Decision and Order on Petition for Judicial Review* issued by Judge Wildman in Minidoka County Case No. CV 2009-647 on May 4, 2010.
- e. Whether the District Court erred by requiring the Director to presume a senior is injured anytime the senior receives less than his maximum authorized rate of diversion, unless and until the junior users proves otherwise by "clear and convincing" evidence.
- f. Whether the curtailment orders comply with the requirements of the Ground Water Act.

4. No order has been entered sealing any portion of the record.

5. The Appellant requests that the transcript of the administrative proceedings held before the Idaho Department of Water Resources be made a part of the record on appeal. The Appellant currently possesses a copy of the transcript, as it was previously prepared in conjunction with the District Court's judicial review of this action. A copy of the transcript may be obtained from Idaho Department of Water Resources. In addition, Appellant requests that a copy of the transcripts from the following hearings held before the district court also be included:

- a. Hearing on Oral Argument, May 26, 2009.
- b. Any additional transcripts that may be required will be requested pursuant to Idaho Appellate Rule 19.

6. The Appellant requests that all pleadings, briefs, and attachments filed in this case plus all other documents in the clerk's record automatically included under Rule 28 of the Idaho Appellate Rules be made part of the record. Appellants also request, to the extent that the following pleadings are not found in the district court docket of the above-captioned matter, the following pleadings be made part of the record:
