On November 6, 2009, a hearing was held in the above-captioned matter.


Pursuant to the hearing, THE FOLLOWING IS HEREBY ORDERED:

2. IDWR is required to file with this Court and serve upon the parties in this matter a document setting forth the shortfall calculations following the application of late season recharge by **Tuesday, January 12, 2010**.
