AND TRANSCRIPT**

NORTH SIDE CANAL COMPANY, AND TWIN  
FALLS CANAL COMPANY

On December 13, 2010, this proceeding was stayed by order of the District Court until the issuance of a decision by the Idaho Supreme Court in the Surface Water Coalition Appeal, Case No. 38193-2010 (“SWC Supreme Court Appeal”). On December 17, 2010, the Idaho Department of Water Resources (“Department”) filed the *Order Settling the Agency Transcript and Record* with the Court. The decision in the SWC Supreme Court Appeal was issued on December 17, 2013. On February 24, 2014, the Court issued the *Order Amending In Part Procedural Order Governing Judicial Review of Final Orders of Director of Idaho Department of Water Resources*, thereby lifting the stay and amending the procedural deadlines in this proceeding.

The Department served its *Notice of Lodging Supplemental Agency Record with the Agency* (“Notice”) in this matter on March 10, 2014, pursuant to I.R.C.P. 84(f)(5). No additional transcripts were added to the agency record. The Notice gave the parties fourteen (14) days from the date of the Notice to file any objection to the agency record.

On March 12, 2014, the Department informed the parties that transcript of the “Hearing on IGWA’s and City of Pocatello’s Petitions for Rehearing on July 24, 2009 Order on Petition for Judicial Review,” held on February 22, 2010, in the Gooding County Case No. CV-2008-551, will be included in the record at the time of filing with the District Court. No objections to the inclusion of this transcript have been made by the Parties.

On March 21, 2014, the City of Pocatello (“Pocatello”) and the Surface Water Coalition (“SWC”) filed objections to the Agency Record.

Pocatello's Objection requested the addition of five (5) documents from the record in the Gooding County Case No. CV-2008-551, and two (2) documents filed in the Idaho Supreme Court consolidated appeal, Docket No. 38191-2010, 38192-2010, and 38193-2010. Pocatello's Objection also informed the Department of a clerical error in the record.

**The Department has no objection to the inclusion of the documents requested by Pocatello and the record at the time of filing with the District Court will reflect the inclusion of these documents. The Department will also address the clerical error.**

The SWC's Objection requested the inclusion of the background calculation data to the Agency Record DVD for the following orders issued by the Department in this contested case on appeal, Docket No. CM-DC-2010-001:

- 1) *Order Revising April 2010 Forecast Supply (Methodology Step 6)*, dated August 10, 2010;
- 2) *Order Revising April 2010 Forecast Supply (Methodology Step 7)*, dated September 17, 2010; and
- 3) *Final Order Establishing 2010 Reasonable Carryover (Methodology Step 9)*, dated December 23, 2010.

**The Department has no objection to the inclusion of the background calculation data to the Agency Record DVD with the exception of the request No. 3. The *Final Order Establishing 2010 Reasonable Carryover (Methodology Step 9)* was issued by the Department on November 30, 2010, not December 23, 2010. The background calculation data from the November 30, 2010 Final Order will be added to the Agency Record DVD.**

The SWC's Objection requested the addition of the following documents and supporting data from the record in this contested case on appeal, Docket No. CM-DC-2010-001:

- 1) *Notice of Change of Name of Firm*, dated January 4, 2013; and
- 2) *Travis L. Thompson Letter to Director Gary Spackman, CD with irrigated acreage information attachment*, dated March 29, 2013.

**The Department has no objection to the inclusion of these documents and supporting data requested by the SWC and the record at the time of filing with the District Court will reflect their inclusion.**

The SWC's Objection requested the addition of the following documents and supporting data from the record in this contested case on appeal, Docket No. CM-DC-2010-001:

- 1) *AFRD #2 Letters to Director Gary Spackman* (2012, 2013); and
- 2) *Minidoka Irrigation District Emails and/or Letter to IDWR, irrigated acreage information attachment* (2012, 2013).

While these two requests do not specifically identify what documents the SWC is requesting, the Department has reviewed its files and located responsive documents. Specifically, with respect

to the first request, the Department located two letters to Director Spackman regarding shape files from AFRD #2 signed by Lynn Harmon dated February 23, 2012, and March 7, 2013. With respect to the second request, the Department located an email from Minidoka Irrigation District to Victoria Wigle dated March 16, 2012, with Minidoka Irrigation District's shape file attached. The Department also located a letter sent by email to Director Spackman signed by Kent Fletcher dated March 26, 2013, with Minidoka Irrigation District's shape file showing total irrigated acres attached.

**The Department has no objection to the inclusion of these documents and supporting data requested by the SWC and the record at the time of filing with the District Court will reflect their inclusion.**

The SWC's Objection requested the addition of the following documents and supporting data from the record in this contested case on appeal, Docket No. CM-DC-2010-001:

- 1) Water District 01 June 11, 2013 Storage Allocation, and any data regarding the calculation of AFRD #2's 2013 storage allocation, referenced in the Director's *Order Releasing IGWA from 2012 Reasonable Carryover Shortfall Obligation (Methodology Step 5)*, dated June 17, 2013.

In response to this request, the Department obtained a copy of the 2013 Storage Report dated June 11, 2013, that was used for the 2013 preliminary storage allocations.

**The Department has no objection to the inclusion of this document and the record at the time of filing with the District Court will reflect its inclusion.**

### **ORDER**

NOW, THEREFORE, IT IS HEREBY ORDERED that timely objections to the agency record having been made, and with the additions or changes to the record, the transcripts and record are deemed settled.

IT IS FURTHER ORDERED that pursuant to Idaho Rule of Civil Procedure 84(j), the City of Pocatello and Surface Water Coalitions' Objections, and this Order shall be included in the record on the petition for judicial review. The Department shall provide the parties with copies of the agency record on two ( 2 ) DVDs consistent with the modifications made in this order.
