

The above-captioned matter before this Court concerns A&B Irrigation District's appeal of a Final Order on Remand Regarding the A&B Irrigation District Delivery Call ("Remand Order") entered by the Director of the Idaho Department of Water Resources ("IDWR") on April 27, 2011 in IDWR proceeding No. CM-DC-2011-001. The Remand Order was issued by the Department pursuant to this Court's May 4, 2010 Memorandum Decision and Order on Petition for Judicial Review ("Memorandum Order") in Case No. 2009-647, in which the Court remanded to the Department to evaluate the evidence in the record and make a determination regarding injury pursuant to the clear and convincing standard of evidence. Memorandum Order at 49-50. See also Memorandum Decision and Order on Petitions for Rehearing, November 2, 2010. Pocatello was also a party to the remand of the matter that proceeded before the Department as IDWR Docket No. CM-DC-2011-001, and participated in the briefing of proposed findings in that matter.

Based on the foregoing, Pocatello requests that the court designate Pocatello as a Respondent-Intervenor in the above captioned matter amend the caption accordingly.
