



THE FOLLOWING ARE HEREBY ORDERED:

1. The *Judgment* entered in the above-captioned case has become final;
2. Consistent with the *Stipulation to Dismiss Appeal* entered on December 4, 2013, in Idaho Supreme Court Docket No. 41069-2013, GARY SPACKMAN, in his capacity as Director of the Idaho Department of Water Resources, and THE IDAHO DEPARTMENT OF WATER RESOURCES shall vacate the *Final Order on Remand Regarding A&B Irrigation District Delivery Call* entered on April 27, 2011, in IDWR Docket no. DC-2011-001.

GARY SPACKMAN, in his capacity as Director of the Idaho Department of Water Resources, and THE IDAHO DEPARTMENT OF WATER RESOURCES shall forthwith comply with the directives of the *Memorandum Decision on Petition for Judicial Review* and corresponding *Judgment*, if any action is required, as well as the *Stipulation to Dismiss Appeal* entered on December 4, 2013, in Idaho Supreme Court Docket No. 41069-2013, if any action is required.
