**NOTICE OF PROCEDURES FOR TELEPHONIC APPEARANCES**

Please take notice that any person desiring to appear via telephone at the Telephonic Status Conference set for **CV-2011-0000062-C SNOWDON WILDLIFE SANCTUARY, ETAL. VS. MCCALL RANCH, LLC, ETAL.** on **Thursday, April 28, 2011** at **04:00 PM** before the Honorable Michael McLaughlin, at the Valley County Courthouse, in Cascade, Idaho should proceed as follows:

1. Contact CourtCall at (888) 882-6878 not later than 3:00 p.m. the day before the hearing.
2. CourtCall will provide you with written confirmation of a telephonic appearance and give you a number to call to make the telephonic appearance.
3. It is your responsibility to dial into the call not later than 10 minutes prior to the scheduled hearing. CourtCall does not call you.
4. The Court discourages the use of cell phones or speakerphones. Please put your telephone on mute when not speaking.
5. Each time you speak, you must identify yourself for the record.
6. Parties participating by telephone are individually responsible for their own expenses and will be billed directly by CourtCall. Make a CourtCall Appearance by serving and filing with CourtCall (not the Court), a Request for Telephonic Appearance Form (via the phone call) and paying a fee of \$55.00 for each CourtCall Appearance. There are no subscription fees.
7. **You have the option to appear in court even if the other party(s) appear by phone.**


