

On May 18, 2012, a *Petition for Judicial Review* was filed in the above-captioned matter. Among other things, the *Petition* contains a request for leave to discover and present additional evidence pursuant to Idaho Code § 67-5276 and a request for an expedited hearing in this matter.

The case was reassigned by the Clerk of the Court to this Court on May 24, 2012. Also on May 24, 2012, the Idaho Ground Water Appropriators, Inc. ("IGWA") filed a *Notice of Appearance* and Motion to Amend Caption to Designate IGWA as a Respondent.

Pursuant to the *Procedural Order Governing Judicial Review of Final Order of Director of Idaho Department of Water Resources* issued concurrently herewith, the time for filing a *Notice of Appearance* by the parties to the underlying proceeding not named in the *Petition* expires June 8, 2012.

Therefore, IT IS HEREBY ORDERED that a status conference is set to be heard in the above-captioned matter on June 8, 2012 at 1:30 p.m. at the Snake River Basin Adjudication District Court, 253 3rd Avenue North, Twin Falls, Idaho. Telephone participation will be available by calling 1-215-446-0193 and entering 406128 followed by the # sign when prompted. However, no cell phones or speaker phones will be permitted as they interfere with our sound system making the proceeding difficult to accurately record. Video teleconferencing ("VTC") will also be available by appearing at the Idaho Department of Water Resources, Idaho Water Center, 322 E. Front St., Conference Rm. B, Boise, Idaho. Parties should refer to the Administrative Order Adopting Procedures for the Implementation of the Idaho Supreme Court Administrative Order Dated December 9, 2009 issued by this Court on July 1, 2010, regarding protocol for telephone and VTC participation.
