Joint Motion to Waive Page Limit and Amend Briefing Schedule Idaho Ground Water Appropriators, Inc. (IGWA), acting for and on behalf of its members, Rangen, Inc, City of Pocatello, Fremont-Madison Irrigation District, and the Surface Water Coalition, by and through their respective attorneys of record, hereby move the Court to 1) waive the page limit for opening briefs to be submitted in support of IGWA's and Rangen's petitions for judicial review, filed in the above-stated matter; and 2) amend the briefing schedule as set forth below.

## A. Joint Motion to Waive Page Limit

The parties request a waiver of the page limit on their opening briefs because the issues on appeal are numerous and varied, and certain issues require substantial background explanation of highly technical matters involving hydrogeologic conditions and computer modeling, such that the standard 50 page limit will prevent the parties from fully developing relevant issues and arguments.

## B. Joint Motion to Amend the Briefing Schedule

The parties further move the Court to amend the briefing schedule as outlined below:

- 1) Opening Briefs Due: Friday July 11, 2014;
- 2) Response Briefs Due: Wednesday August 6, 2014;
- 3) Reply Briefs Due: August 21, 2014

Since the IDWR issued its Final Order Regarding Rangen, Inc.'s, Petition for Delivery Call; Curtailing Ground Water Rights Junior to July 13, 1962, on January 29, 2014, IGWA and Rangen have been engaged in litigation over three mitigation plans submitted by IGWA, two of which have already gone through multi-day hearings. This, combined with the voluminous agency record, numerous, technical issues on appeal, and other obligations of counsel for the parties, has imposed a substantial strain on the parties' ability to submit opening briefs by the present July 1 deadline.
