**PETITION FOR JUDICIAL REVIEW
OF AGENCY ACTION**

Petitioner Eckhardt Family LLLP (“Eckhardt” or “Petitioner”), by and through its counsel Norman M. Semanko of Parsons Behle & Latimer, and pursuant to Idaho Code §§ 42-1701A(4) and 67-5270 through 67-5279, and Rule 84 of the Idaho Rules of Civil Procedure, hereby files this

petition (“Petition”) seeking judicial review of an agency action by the Idaho Department of Water Resources (“Department” or “Respondent”).

SUMMARY OF THE CASE

1. This is a civil action pursuant to Idaho Code §§ 42-1701A(4) and 67-5270 through 67-5279 seeking judicial review of the December 20, 2019, *Order on Reconsideration; Amended Final Order* (“*Amended Final Order*”) issued by Gary Spackman, the Director of the Department (the “Director”).

2. On September 12, 2018, Eckhardt Family LLLP (“Eckhardt”) filed Applications for Permit Nos. 67-15298 and 67-15300 with the Department, seeking authorization for various stock water ponds. The Department published notice of the applications on December 6 and 13, 2018. Double C & J Land Co., Inc, through its President John D. Hoff (“Protestant”), filed protests against both of the applications.

3. The Department conducted a consolidated administrative hearing on May 23, 2019.¹

4. On July 8, 2019, hearing officer James Cefalo (“hearing officer”) issued a *Preliminary Order Denying Applications 67-15298 and 67-15300* (“*Preliminary Order*”).²

5. On July 22, 2019, Eckhardt timely filed a *Petition for Reconsideration*.

¹ Although a single hearing was held on May 23, 2019 to address the instant matter along with the related matter of *In the Matter of Applications for Permit 67-15292 through 67-15297*, the two matters were not formally consolidated and separate orders were issued in each matter. Accordingly, Petitioner is filing separate *Petitions for Judicial Review of Agency Action* for each of the two matters.

² The hearing officer issued two orders, one in the instant matter and one in *In the Matter of Applications for Permit 67-15292 through 67-15297* owing to there being “important factual distinctions related to the ponds.” *Amended Final Order* at 1.

6. On August 2, 2019, the Protestant filed a *Response to Petition for Reconsideration*, which was not considered, as “responses to petitions for reconsideration are not recognized under the Department’s rules of procedure. *See* IDAPA 37.01.01.730.” *Amended Final Order* at 1, n.2.

7. On August 8, 2019, the hearing officer issued a single *Order Granting Petitions for Reconsideration (In the Matter of Applications for Permit 67-15292 through 67-15298 and 67-15300)*.

8. On August 8, 2019, the hearing officer also issued two *Amended Preliminary Orders Denying Applications*, one in *In the Matter of Applications for Permit 67-15298 and 67-15300*, and one in the *Matter of Applications for Permit 67-15292 through 67-15297*.

9. On August 23, 2019, Petitioner timely filed the *Eckhardt Family LLLP's Exceptions to Amended Preliminary Orders Denying Applications and Order Granting Petitions for Reconsideration In Part (“Eckhardt Exceptions”)*. In response to the Eckhardt Exceptions, on September 5, 2019, the Protestant timely filed *Double C & J Land Co., Inc.’s Response to Eckhardt’s Exceptions to Amended Preliminary Order*.

10. On November 14, 2019, the Director issued his *Order on Exceptions; Final Order (In the Matter of Applications for Permit 67-15298 and 67-15300) (“Order on Exceptions”)*.

11. On November 29, 2019, Eckhardt timely filed a single *Petition for Reconsideration of Orders on Exceptions; Final Orders (In the Matter of Applications for Permit 67-15292 through 67-15298 and 67-15300 in the Name of Eckhardt Family LLLP)*.

12. On December 20, 2019, the Director issued his *Amended Final Order* in the Matter of Applications for Permit Nos. 67-15298 and 67-15300.

STATEMENT OF INITIAL ISSUES

13. Petitioner asserts the following initial issues on judicial review:
 - a. Whether the Department's *Amended Final Order* is in violation of constitutional or statutory provisions.
 - b. Whether the Department's *Amended Final Order* is in excess of the statutory authority of the agency.
 - c. Whether the Department's *Amended Final Order* was made upon unlawful procedure.
 - d. Whether the Department's *Amended Final Order* is without the support of substantial evidence on the record as a whole.
 - e. Whether the Department's *Amended Final Order* is arbitrary, capricious, or an abuse of discretion.
 - f. Whether the Department's *Amended Final Order* prejudiced substantial rights of the Petitioner.

JURISDICTION AND VENUE

14. This *Petition* is authorized by Idaho Code §§ 42-1701A(4) and 67-5270 through 67-5279.

15. The Order is a final agency action and therefore this Court has jurisdiction over this action pursuant to Idaho Code §§ 42-1701A(4) and 67-5270 through 67-5279.

16. Venue lies in the Court pursuant to Idaho Code § 67-5272. Petitioner's principal place of business is 1275 Jenkins Creek Road, Weiser, Washington County, Idaho. Also, the real property and the proposed water use in the pond applications at issue are located in Washington County, Idaho.

17. Pursuant to the Idaho Supreme Court's Administrative Order issued on December 9, 2009, "all petitions for judicial review of any decision regarding administration of water rights from the Department of Water Resources shall be assigned to the presiding judge of the Snake River Basin Adjudication Court of the Fifth Judicial District." The Snake River Basin Adjudication Court's procedures instruct the clerk of the district court in which the petition is filed to issue a Notice of Reassignment. A form of Notice of Reassignment is attached herewith for the Court's convenience and marked Exhibit A.

AGENCY RECORD

18. Petitioner has contacted the Department regarding preparation of the agency record and tendered the estimated fee to be paid to the agency. Petitioner will pay the estimated fee in advance, as provided by the Department, in accordance with Rule 84 of the Idaho Rules of Civil Procedure.

SERVICE

19. The undersigned hereby certifies that service of this Petition has been made on the Respondent and all other parties to the proceeding before the agency as shown on the Certificate of Service.

TRANSCRIPT

20. A transcript of the hearing in this matter is requested by Petitioner. The Department has provided its digital audio recording of the May 23, 2019 hearing to M&M Court Reporting, and Petitioner has remitted the required deposit to M&M and requested preparation of a transcript of said hearing in accordance with Rule 84 of the Idaho Rules of Civil Procedure.

DEMAND FOR ATTORNEY FEES AND COSTS

21. As a result of Respondent's actions, Petitioner has had to retain counsel. For services rendered, Eckhardt is entitled to its reasonable attorney fees and costs should it prevail in this action pursuant to Idaho Code § 12-117 and Rule 54 of the Idaho Rules of Civil Procedure.
