**MEMORANDUM IN SUPPORT OF

The Petitioners, Boise Project Board of Control and New York Irrigation District submit this Memorandum in Support of their Motion to File Overlength Brief requesting leave of the Court to exceed the 50 page limit set forth in Idaho Appellate Rule 34(b).

In their Respondents' Briefs the Department of Water Resources and Suez filed approximately 200 pages of briefing. The Boise Project has worked diligently to attempt to meet

the 50 page maximum set forth at Idaho Appellate Rule 34(b) in drafting its Reply brief, however, finds that the brief is likely to exceed that limit by 5 to 10 pages. Based on the volume of argument that the Boise Project is responding to in its Reply brief, good cause exists for this court to allow the Boise Project to submit a Reply brief in excess of the 50 page limit, up to 60 pages.


CONCLUSION


For the reasons set forth above, the Boise Project and New York request that this Court grant its Second Motion For Leave to File Overlength Brief.


