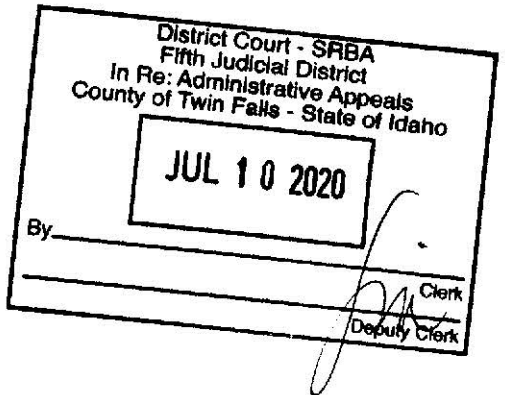

TO INTERVENE**


