STIPULATED MOTION TO AMEND DATE FOR ORAL ARGUMENT ON PETITION FOR JUDICIAL REVIEW

The parties, through their undersigned attorneys of record, in accordance with I.R.C.P. 84(o) and 2.5, I.A.R. 46, the Procedural Order issued by the Court in this matter on May 16, 2023, and Order Granting Motion for Extension issued by the Court on May 31, 2023, hereby stipulate and jointly move the Court to amend the date for oral argument on the Petition for Judicial Review. 4. The current briefing schedule and the extended due date for lodging the settled agency record and transcript with the Court results in Petitioner's reply brief being due on October 3, 2023, after the currently scheduled oral argument date.

Accordingly, the parties in this matter respectfully request an order from the Court amending the date for oral arguments on the Petition for Judicial Review to October 30, 2023, at 1:30 p.m., after the parties' briefing is completed.
