
The parties, through their undersigned attorneys of record, in accordance with I.R.C.P. 84(o) and 2.5, I.A.R. 46, the Procedural Order issued by the Court in this matter on May 16, 2023, and Order Granting Motion for Extension issued by the Court on May 31, 2023, hereby stipulate and jointly move the Court to amend the date for oral argument on the Petition for Judicial Review. For the following reasons, there is good cause to grant the stipulated request:

1. Pursuant to this Court's Order Granting Motion for Extension, the deadline to lodge with the Court the settled agency record and transcript in this matter was extended to July 11, 2023.
2. Pursuant to this Court's Procedural Order, the parties' briefing schedule requires Petitioner's brief to be filed with the Court within 35 days of lodging the settled agency record and transcript with the Court; Respondent's brief to be filed with the Court within 28 days of Petitioner's brief; and then Petitioner's reply brief to be filed within 21 days of Respondent's brief. Procedural Order, ¶ 9.
3. Pursuant to this Court's Procedural Order, oral arguments on the Petition for Judicial Review are set for September 28, 2023, at 1:30 p.m. *Id.* at ¶ 12.
4. The current briefing schedule and the extended due date for lodging the settled agency record and transcript with the Court results in Petitioner's reply brief being due on October 3, 2023, after the currently scheduled oral argument date.

Accordingly, the parties in this matter respectfully request an order from the Court amending the date for oral arguments on the Petition for Judicial Review to October 30, 2023, at 1:30 p.m., after the parties' briefing is completed.


