



3. Oral argument will be heard on **Monday, October 30, 2023, at 1:30 p.m. (Mountain Time)** at the Snake River Basin Adjudication District Court, 253 3rd Avenue North, Twin Falls, Idaho. Oral argument will be conducted via Zoom with instructions to be provided parties at a later date. The form and order of argument shall be governed by I.A.R. 37.
