**ORDER VACATING AND  
RESETTING HEARING**

**ORDER SETTING HEARING  
ON INTERVENOR'S MOTION

On May 16, 2024, the Respondent filed a Motion to Dismiss and a Motion to Correct Caption. A hearing on the Motions is presently set for June 6, 2024. On May 21, 2024, the Intervenor filed a Motion to Dismiss. The Intervenor's Motion to Dismiss is not presently set for hearing. The Court will set the Intervenor's Motion to Dismiss for hearing as set forth herein. On May 24, 2024, the Respondent filed an Uncontested Motion to reset the June 6, 2024, hearing to June 14, 2024, at 1:30 p.m. (Mountain Time). In the Motion to Reset, counsel for the

Respondent represents she has contacted counsel for the other parties and that they do not oppose the Motion to Reset. The Court in an exercise of its discretion will grant the Motion to Reset on the basis it is unopposed.

THEREFORE, THE FOLLOWING ARE HEREBY ORDERED:

1. The Motion to Reset is hereby granted.
2. The hearing set for June 6, 2024, is hereby vacated.
3. NOTICE IS HEREBY GIVEN that a hearing on the Respondent's Motion to Dismiss, the Respondent's Motion to Correct Caption, and the Intervenor's Motion to Dismiss is set for **June 14, 2024, at 1:30 p.m. (Mountain Time)** at the Snake River Basin Adjudication District Court, 253 3rd Avenue North, Twin Falls, Idaho. Oral argument will be conducted via Zoom pursuant to the attached instructions.

### 2. How to join the meeting online

- In your browser enter the link <https://www.zoom.us/join>

- Follow the instructions on the screen to either download and install the Zoom client, or to join the meeting via your web browser.
- When prompted, enter the meeting password provided above.
- Once the connection is made, you will be placed in a Waiting Room. A message will appear "Please wait, the meeting host will let you in soon."
- When court begins, you will be brought into the meeting from the Waiting Room.

### 3. Video (when joining online)

- Start your video by clicking **Start Video**, located in the lower-left corner of the window.

### 4. Audio

- Your sound will be on mute upon entry.
- Remain muted unless you are asked to speak to the court. Please be sure you have no background noise while speaking. You may be muted or removed from the hearing if causing a disruption.
- To unmute yourself, click the **Unmute** button, located in the lower-left corner of the window.
- If joining only by telephone, press \*6 to toggle between unmute/mute.
