DECLARATION OF DAVID T. GRAYBILL

- I, David T. Graybill, being first duly sworn upon oath, depose and state as follows:
- 1. I am over the age of eighteen (18) years and competent to testify to the matters contained herein. I make this declaration pursuant to Idaho Code § 9-1406 and based on my own personal knowledge.

- 2. I am currently the Technical Hydrologist and Watermaster of the Upper Salmon River Basin Water District 170 for the Idaho Department of Water Resources ("Department"). I am based out of the Department's Salmon Office, 1301 Main Street STE 10, Salmon, ID 83467. I have served in this capacity since July 2021.
- 3. When I visited the PantherC, LLC property in June 2023, I observed that the trench Mr. Comte dug had diverted the entire flow of Panther Creek.
- 4. The water diverted into the trench was not being used to irrigate any of the PantherC, LLC property.
- 5. Based on the size of the trench and the velocity of the water, I estimate the flow of water was at least 20 cfs.
- 6. PantherC, LLC and Mr. Comte performed temporary remedial measures to return flow into Panther Creek from the trench on October 30 and October 31, 2023.
- 7. Without permanent measures that stabilize the disturbed soil, the remedial measures implemented by PantherC, LLC and Mr. Comte will likely fail causing further erosion and sediment transport. In addition, the aquatic habitat of Panther Creek will remain degraded.
- 8. On November 7, 2023, I visited the PantherC, LLC property to observe and document the temporary remediation measures. While on the property I measured the flow of Panther Creek. My measurement showed the flow was 11.7 cfs. A copy of the reading from my instrument is attached as **Exhibit 1**.1
- 9. Prior to my flow measurement on November 7, 2023, the area had not received precipitation for more than a week. Therefore, the flow measurement is a good

approximation of the winter base flow of Panther Creek at the PantherC, LLC property.

Panther Creek has its lowest flows in winter.

10. The water right associated with the PantherC, LLC property (No. 75-14226) allows for diversion of 1.4 cfs for irrigation of 70 acres. A copy of the water right report for Water Right No. 75-14226 is attached as **Exhibit 2**.

I declare under penalty of perjury pursuant to the law of the State of Idaho that the foregoing is true and correct.




Exhibit 1

Panther Creek Flow Measurement


