**NOTICE OF CONTINUED  
PREHEARING CONFERENCE**

On March 8, 2022, Cat Creek Energy, LLC (“Cat Creek”) held a settlement conference in this matter. Representatives of Cat Creek, the Idaho Department of Water Resources (“Department”), and many of the protestants participated in the settlement conference via Webex and in person at the Department’s state office. Cat Creek and other parties in attendance expressed general openness to negotiation and settlement of disputed issues. The conference ended without indication that any protest will be resolved by settlement. The Director will convene a continued prehearing conference to discuss prospects for settlement and determine a schedule for this proceeding.

NOTICE IS HEREBY GIVEN that the Department will hold a continued prehearing conference to discuss the schedule for this proceeding, including whether the matter should be set for hearing or whether Cat Creek Energy intends to request a delay in processing of its application pending under IDAPA 37.03.08.040.01.d. The status conference will be held on **June 21, 2022, at 10 a.m. (MST)** in Conference Rooms 602C and 602D of the Department’s State Office, located at 322 E. Front Street, 6<sup>th</sup> Floor, Boise, Idaho.

All parties must be present at the prehearing conference in person, by telephone, or by video conference. Instructions on how to access the prehearing conference from video or telephone will be provided at a later date, via email to all persons listed on the certificate of service below.

The continued prehearing conference will be held in accordance with the provisions of Chapter 17, Title 42, and Chapter 52, Title 67, Idaho Code, and the Department’s Rules of Procedure. IDAPA 37.01.01. A copy of the Rules of Procedure may be obtained from the Department upon request or at <https://adminrules.idaho.gov/rules/current/37/index.html>.

The conference will be conducted in a facility that meets the accessibility requirements of the Americans with Disabilities Act. 
