NOTICE OF PROTEST

Name and address of protestant and matter being protested: The Elmore County
Board of County Commissioners (“Elmore County”), through undersigned counsel of
record, hereby files this Notice of Protest to Application for Permit No. 63-34900 (the
“Application”), filed by Cat Creek Energy, LLC (the “Applicant”), pursuant to Idaho Code
Section 42-203A(4) and IDWR Rules of Procedure 210, 250. Elmore County’s mailing

address is 150 S. 4th East, Mountain Home, Idaho 83647. The \$25 protest fee is being submitted contemporaneously with this Notice.

Protestant's representative and service: Elmore County's representatives for service in this matter shall be counsel of record identified in the heading of this Notice.

Bases of protest: The Application proposes to divert water from the South Fork Boise River within Elmore County, for uses within Ada County and Canyon County. Elmore County holds a permit for water appropriation from this same source. If granted, the Application must be conditioned in a manner consistent with Idaho Code Section 42-203A(5)(a)-(f), the Department's Water Appropriation Rules, and conditions imposed on other water rights within Basin 63.

In particular, pursuant to Idaho Code Section 42-203A(5)(a), the Application must not injure other water rights, including those held by Elmore County. In addition, the Application does not adequately explain or establish the sufficiency of the water supply or the financial resources that will be used to complete the project pursuant to Idaho Code Section 42-203A(5)(b), (d).


Moreover, pursuant to Idaho Code Sections 42-203A(4) and 42-203A(5)(e), (g), and because the source of water proposed in the Application originates in Elmore County, the Application conflicts with the local public interest as defined in Idaho Code Section 42-202B and will adversely affect the local economy of the local area within which the source of water originates, unless some of the water appropriated under any permit is designated for beneficial uses within Elmore County.

Finally, because the Application is tied to and specifically incorporates other water right applications filed by Applicant that have not yet been granted, the Application is speculative at this time in violation of Idaho Code Section 42-203A(5)(c).


What would resolve this Protest: If conditions addressing and reflecting the above bases of protest are included in any permit, Elmore County would support action by the Director granting the permit. Otherwise, the application must be denied.
